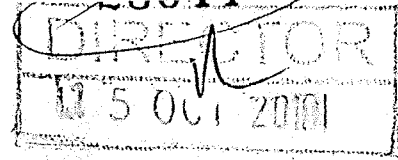

ORDER:-

In his letter read above Director of Town and Country Planning has furnished the details such as area, population connectivity to various places take Sathyamangalam, Melapalayam, and Tirupur, Industries, topoplan etc., in respect of Punjaipuliyampatti Third Grade Municipality in Erode District. With a view to ensure orderly development it would be advantageous to prepare a Master Plan for the area. He has requested that as a first step in this regard Punjaipuliyampatti may be declared as Local Planning Area under section 10(1) of the Town and Country Planning Act 1971 (Tamil Nadu Act 35 of 1972)

2. The Government after careful consideration and have decided to accept the proposal of the Director of Town and Country Planning in para 1 above declare the local area comprising in Third Grade Municipality Area of Punjaipuliyampatti to be a local planning area. The appended notification will be published in English in the Tamil Nadu Government Gazette and republished in English and in Tamil in the Erode District Gazette.

3. The Collector of Erode District is requested to republish the notification in the District Gazette.

4. The Director of Translation, Chennai is requested to arrange to have the notification translated into Tamil version and forward the same urgently to the Collector of Erode District.

5. The Collector of Erode District is requested to report to Government, the date of republication of the notification in the District Gazette.
