

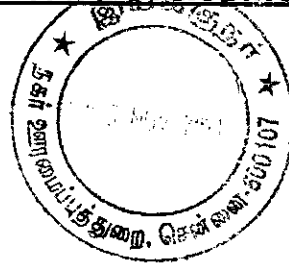

ORDER:

During the Demand Session 2021-2022, while moving Demand No.26, the Hon'ble Minister (Housing and Urban Development) made the following announcement in the floor of the Assembly:

"There is no Master Plan to the Areas Sholinghur, Vadalur, Thirukoilur and Gudalur, Nilgiris District. To protect natural resources, its ancient and to ensure planned development Master Plans will be prepared".

2. Based on the above announcement, in the letter read above, the Director of Town and Country Planning has requested to declare the Local Area comprising in Sholinghur Municipality to be a Sholinghur Local Planning Area.

3. The Government after careful consideration of the above proposal of the Director of Town and Country Planning, have decided to declare their intention to declare the areas specified in the notification appended to this order as Sholinghur Local Planning Area under clause (b) of sub-section (1) of section 10 of the Tamil Nadu Town and Country Planning Act, 1971 (Tamil Nadu Act 35 of 1972).

4. The appended Notification will be published in English in the Tamil Nadu Government Gazette and republished in English and in Tamil in the Ranipet District Gazette.

5. The Collector of the Ranipet District is directed to republish the Notification in the District Gazette.

6. The Director of Translation, Chennai-9 is directed to arrange to have the Notification translated into Tamil and to forward the translation urgently to the Collector of Ranipet District under intimation to the Government.

7. The Collector of Ranipet District is directed to report to Government the date of republication of the Notification in the District Gazette.
