ORDER :-

The Commissioner of Town and Country Planning in her letter second read above has stated that the Principal Secretary / Managing Director, Tamil Nadu Slum Clearance Board in letter dated 15.10.2018 had sent a proposal seeking fund amounting to Rs.21.36 crore under Infrastructure and Amenities Fund for providing development works to 58 slums covering 15,950 families i.e., providing basic amenities like road, storm water drain, culverts, cement concrete pathway, street light etc., to improve the living conditions of the urban slums and make it habitable under Environmental Improvement of Urban Slums (EIUS) which would be handed over to the urban local bodies concerned for future maintenance.

2. The Commissioner of Town and Country Planning has also stated that the Government provided grants through Budgetary support every year till 2014-2015 and during 2015-2016. The Infrastructure and Amenities Funds of Directorate of Town and Country Planning for development of Urban Slums to be executed by Tamil Nadu Slum Clearance Board could not be obtained from the Directorate of Town and Country Planning and hence the works were not executed during 2015-2016. Recently a proposal for providing development works in 300 slums covering 75282 families at a cost of Rs.2426.85 lakh was approved by the Government under the Infrastructure and Amenities Funds of Directorate of Town and Country

Planning. The works will be completed on time. The detailed proposals have been placed before the Board for execution of work.

3. The Commissioner of Town and Country Planning has further stated that in the meantime, additional proposals were received for 58 slum areas covering 15950 families in Erode District which was scrutinized along with the Local body and financial statements prepared.

4. The cost of the proposal is estimated at Rs.21.36 crore priced as per the prevailing Schedule of Rates 2018-2019.

5. The above proposal was sent to the Chairman, State Infrastructure and Amenities Promotion Committee for approval through circulation notes on 03.10.2018. In this regard, The Chairman / Principal Secretary, Housing and Urban Development Department has instructed to obtain the revised estimate from Tamil Nadu Slum Clearance Board and it has been done vide letter dated 09.10.2018.

6. The Managing Director, Tamil Nadu Slum Clearance Board in his letter dated 15.10.2018 has stated that the proposal costing Rs.21.36 crore covering 58 urban slums pertaining to Erode District has no correlation to the proposal approved by the Government and pending for Board's approval. This is an independent and new proposal whose rates and specifications have been vetted, taking into account the lead from source and location of the sites and the rates are as per Public Works Department schedule of rates based on the Highways data. He has, therefore, requested the Director of Town and Country Planning to provide Infrastructure and Amenities Fund for the above said project in Erode district.

7. A circulation note for sanction of an amount of Rs.21.36 crore as grant from Infrastructure and Amenities Fund approved by the members of State Infrastructure and Amenities Promotion Committee.

8. The Commissioner of Town and Country Planning has, therefore, requested the Government to sanction Rs.21.36 crore under Infrastructure and Amenities Fund to provide basic amenities to the 58 urban slums as requested by the Principal Secretary/Managing Director, Tamil Nadu Slum Clearance Board.

9. The Government after careful examination, accept the proposal of Commissioner of Town and Country Planning and accord sanction for a sum of Rs 21,36,00,000/- (Rupees Twenty one crore and thirty six lakh only) for providing development works at 58 slums covering 15,950 families in Erode district under Infrastructure and Amenities Fund for the year 2018-2019.

10. The expenditure sanctioned in paragraph 9 above shall be debited under the following Head of account:-

(a) "2217 Urban Development-05 Other Urban Development Schemes - 800 Other Expenditure-State's Expenditure-JW Assistance from Infrastructure and Amenities Fund for Schemes

implemented through TNSCB-09 Grants in Aid - 02 Grants for creation of Capital Assets.

(DPC 2217-05-800-JW-0921)."

And contra debiting J. Reserve Funds.

(b) Reserve Funds not bearing interest 8229-00 Development and Welfare Fund - 200 Other Development and Welfare Fund-AZ-State Infrastructure and Amenities Fund.

(DPC 8229-00-200-AZ-0005). "(Outgo)

11. The expenditure sanctioned in Para 9 above shall be met from the State Infrastructure and Amenities Fund by adjusting under the Head of Account:-

"2217 Urban Development - 05 Other Urban Development Schemes - 902 Deduct - Amount met from Infrastructure and Amenities Fund-JB-Amount met from State Infrastructure and Amenities Fund 30 - Inter Accounts Transfers".

(DPC 2217-05-902-JB-3004).

12. The expenditure sanctioned in Para 9 above shall not be paid in Cash but Credited to the following head of account:-

"K Deposits and Advances (b) Deposits not bearing interest - 8443.00 Civil Deposits - 800. Other Deposits - CA. Deposit of Tamil Nadu Slum Clearance Board (TNSCB)."

(DP 8443-00-800-CA-000J) (Receipts).

13. Necessary additional funds of Rs.21,36,00,000/- will be provided in RE/FMA 2018-2019 to meet the expenditure sanctioned in para 9 above. Pending provision of such funds, The Commissioner of Town and Country Planning, Chennai-2 is authorized to draw the amount sanctioned in para 9 above by means of an account payee cheque in favour of Personal Deposit Account of Tamil Nadu Slum Clearance Board by indicating the Account Number thereon and disburse the same to Tamil Nadu Slum Clearance Board. This expenditure should be brought to the notice of Legislature by the way of Specific inclusion in the Supplementary Estimates 2018-2019. The Commissioner of Town and Country Planning is requested to include the amount sanctioned in para 9 above, while sending the Budget Proposal of RE/FMA 2018-2019, and also to send necessary Explanatory Notes for inclusion of the above expenditure in the Supplementary Estimates 2018-2019 to Finance (BG-I&Hg&UD) Department without fail.

14. The Managing Director, Tamil Nadu Slum Clearance Board is requested to furnish a copy of the Government Order along with the details of expenditure incurred under para 9 above to the Commissioner of Town and Country Planning for making necessary adjustments regarding contra debit entries mentioned in para 10 through Accountant General (A&E) Chennai at the end of the Financial year 2018-2019 and also to take necessary action to implement the above scheme after following the

procedures in force and send a report to the Government along with an expenditure statement in due course.

15. This order issues with the concurrence of Finance Department vide its U.O.No64559/Hg&UD/2018, dated 26.12.2018 and ASL No.2309 (Two thousand three hundred and nine).
