**ORDER**

The Commissioner of Town and Country Planning in his letter 1<sup>st</sup> read above, forwarded the proposal of District Collector, Perambalur District seeking a sum of Rs.13160.00 lakhs under Infrastructure and Amenities Fund for the following projects:-

2)The Commissioner of Town and Country Planning in his letter 5<sup>th</sup> read above has stated that the 13<sup>th</sup> meeting of the State Infrastructure and Amenities Promotion Committee held on 06.11.2014 vide Agenda No.6, it was decided to sanction as follows:-

3) The Commissioner of Town and Country Planning has further stated that it was proposed to defer two works (Sl.No.1 and 2) and reject one work (S.No.4) and approve one work (Sl.No.3) and the Chief Engineer (C&M) Highways Department was requested to prepare DPR at the current schedule of rates for the approved work (Sl.No.3) so as to avoid the RAS and escalation charges in future. The Chief Engineer (C&M) Highways Department furnished the Detailed Project Report based on the current schedule of rate (2016-2017) for Rs.396.00 lakhs.

4) The Commissioner of Town and Country Planning has stated that the above subject was placed before the 15<sup>th</sup> I&A committee meeting held on 17.08.2017 vide Agenda No.22 and the committee decided to sanction Rs.396.00 lakhs from Infrastructure and Amenities funds for "Construction of bridge at Km 11/4 of Palaiyur-Anukkur-Vilakandapuram road including improvements of road at Km 8/6-9/0 and 11/4-12/0".

5) The Government after careful examination, accept the proposal of Commissioner of Town and Country Planning as recommended by the Chief Engineer (Construction and Maintenance) and accord Administrative Sanction for a sum of Rs.396.00 lakhs (Rupees Three crores and ninety six lakhs only) for the Construction of bridge at Km 11/4 of Palaiyur – Anukkur - Valikandapuram road including improvements of road at Km 8/6-12/0 and drain at Km 8/6-9/0 and 11/4-12/0 in Perambalur District under State Infrastructure Amenities Fund.

6) The expenditure sanctioned in Para 5 above shall be debited to the following head of account:

7) The expenditure sanctioned in Para-5 above shall constitute an item of "New Service" and the approval of the Legislature shall be obtained in due course of time by an inclusion in the Supplementary Estimates for the year 2017-18. Pending approval of the Legislature, the expenditure shall initially be met by drawal of an advance from the Contingency Fund. The Chief Engineer (C&M) Highways is directed to calculate the actual amount required for the period up to next Supplementary Estimates and apply for sanction of the same as advance from the Contingency Fund to Finance (BG-I) Department, directly in Form "A" appended to the Tamil Nadu Contingency Fund Rules 1963 along with a copy of this order Orders regarding this will be issued by the Finance (BG-I) Department separately. The Chief Engineer (C&M) Highways is directed to send necessary explanatory notes for inclusion of the above expenditure in the Supplementary Estimates for the year 2017-18 to Finance (BG-I/ PW-II) Department at the appropriate time without fail.

8) The Chief Engineer (C&M) Highways is directed to send expenditure details to the Director of Town and Country Planning for reconciling the Infrastructure and Amenities Fund with Accountant General at the end of Financial year.

9) The Chief Engineer (C&M) Highways is in the above expenditures within the sanctioned amount and there shall not be any Revised Administrative Sanction in the future.
