Jawaharlal Nehru National Urban Renewal Mission-Release of Rs.53.15 Crore as Additional State share from Infrastructure and Amenities Fund for construction of 2232 tenements at Ukkadam & Vellalore Phase-I in Coimbatore at a revised project cost of Rs.120.66 crore under Jawaharlal Nehru National Urban Renewal Mission - Sanction - Orders - Issued.

ORDER:

In the Government order first read above, revised administrative sanction was accorded for change in location for the construction of 2232 tenements under Jawaharlal Nehru National Urban Renewal Mission initially proposed at Ukkadam to Ukkaadam and Vellalore in Coimbatore District at a revised project cost of Rs.120.66 crore and grant of financial sanction for release of additional state share of Rs.53.15 crore (Rs.120.66 crore - Beneficiaries Share - Rs.3.63 crore - Rs.63.88 crore already released) from the Infrastructure and Amenities Fund. It was also ordered that the Principal Secretary / Managing Director, Tamil Nadu Slum Clearance Board, to submit necessary proposal to Municipal Administration and Water Supply Department for the release of additional state's share of Rs.53.15 crore for the above schemes under Demand No. 34.

2. The Principal Secretary / Managing Director, Tamil Nadu Slum Clearance Board in the letter second read above has requested to release the sanctioned amount of Rs.53.15 crore under Infrastructure and Amenities Fund of Directorate of Town & Country Planning to enable them to complete the schemes and make them ready for occupation.

3. The Government after careful examination, accept the proposal of the Principal Secretary / Managing Director, Tamil Nadu Slum Clearance Board accord sanction for the release of Rs.53,15,00,000/- (Rupees fifty three crore and fifteen lakh only) as additional State's Share from the Infrastructure and Amenities Fund for the construction of 2232 tenements at Ukkadam and Vellore Phase-I in Coimbatore under Jawaharlal Nehru National Urban Renewal Mission to enable the Tamil Nadu Slum Clearance Board to complete the schemes at the earliest.

4. The amount sanctioned in para 3 above shall be debited to the following Heads of Account under Demand No: 34.

General Component (74%) - Rs.39,33,10,000/-

"2217 - Urban Development - 04 - Slum Area Improvement - 192. Assistance to Municipalities / Municipal Councils - State's Expenditure JC. Jawaharlal Nehru National Urban Renewal Mission (JNNURM) - Basic Services to Urban Poor - Controlled by Commissioner of Municipal Administration - 09 Grants-in -Aid - 02 Grants for Creation of Capital Assets. (DPC 2217 04 192 JC 0923)

Special Component (26%) - Rs.13,81,90,000/-

"2217 Urban Development -04-Slum Area Improvement -789 Special Component Plan for Schedule Castes - State's Expenditure JH. Jawaharlal Nehru National Urban Renewal Mission (JNNURM) - Basic Services to Urban Poor under Special Component Plan Controlled by Commissioner of Municipal Administration - 09 Grants in Aid - 02 Grants for Creation of Capital Assets. (DPC 2217 04 789 JH 0928)".

The expenditure sanctioned in para 3 above shall be met from the State Infrastructure and Amenities Fund by an adjustment only under the following Head of Account:-

"2217 - Urban Development - 04. Slum Area Improvement- 902 - Deduct - Amount met from Reserve Fund - State's Expenditure JB. Deduct- Amount met from State Infrastructure and Amenities Fund - Additional State Matching Share under JNNURM-BSUP Scheme - 30 Inter Account Transfers. (DPC: 2217 04 902 JB 3005)

Per contra debit, to the following Head of Account:-

"J. Reserve funds (b) Reserve Funds not bearing interest-8229-00. Development and Welfare Funds - 200. Other Development and Welfare Fund - AZ. State Infrastructure and Amenities Fund (DPC -8229-00-200-AZ-0005) (Outgo).

5. Necessary additional funds of Rs.53.15 crore will be provided in RE/FMA 2017-18, to meet the expenditure sanctioned in para 3 above. Pending provision of funds in RE/FMA 2017-18, the Commissioner of Municipal Administration is authorized to draw the amount sanctioned in para 3 above by

means of an account payee cheque drawn in favour of "Commissioner of Municipal Administration's Basic Service to the Urban Poor / Integrated Housing & Slum Development Programme Savings Account No.50100062940381" maintained in the HDFC Bank, Chennai. This expenditure should be brought to the notice of Legislature by Specific Inclusion in the Supplementary Estimates 2017-18. The Commissioner of Municipal Administration is directed to include the expenditure sanctioned above, while sending the Budget Proposals for RE /FMA 2017-18 and also to send necessary Explanatory Notes for including the above expenditure in the Supplementary Estimates 2017-18 to Finance (MAWS/BGI) Department.

6. The Commissioner of Municipal Administration shall furnish a copy of this Government Order along with the details of expenditure incurred out of the funds sanctioned in para 3 above to the Director of Town and Country Planning and the Accountant General (A&E), Chennai for making necessary adjustment entries mentioned in para 4 at the end of Financial Year 2017-2018.

7. This order issues with the concurrence of Finance Department vide its U.O.No.60126/Fin(MAWS)/2017, dated 20.12.2017 and with ASL No.2305. (Two thousand three hundred and five)
