**ORDER:**

In the letter read above, the Commissioner of Town and Country Planning has stated that, a proposal seeking funds amounting to Rs.9.95 Crore has been received from the Director of Town Panchayats for the sanction of fund under Infrastructure and Amenities Fund for the following projects:-

2. The Commissioner of Town and Country Planning has also stated that Zamin Uthukuli Town Panchayat near Pollachi has lesser income and it is insufficient to maintain the road and storm water drain regularly.

3. Further, the Commissioner of Town and Country Planning has stated that, the above subject was placed before the 15<sup>th</sup> Infrastructure and Amenities Committee meeting held on 17.08.2017 vide Agenda No.23 and the committee discussed in detail and decided to sanction Rs.125.00 lakh from Infrastructure and Amenities funds for laying B.T.Surface Road at Gandhi Nagar area and also requested the Government to issue necessary orders.

4. The Government after careful examination, accept the proposal of the Commissioner of Town and Country Planning and sanction a sum Rs.1,25,00,000/- (Rupees One crore and twenty five lakh only) from Infrastructure and Amenities fund for laying B.T.Surface Road at Gandhi Nagar area of Zamin Uthukuli Town Panchayat in Coimbatore District.

5. The amount sanctioned in para 4 above, shall be debited in the following head of account:-

Infrastructure and Amenities fund:-

"4515-00 CAPITAL OUTLAY ON OTHER RURAL DEVELOPMENT PROGRAMMES - 800 -Other expenditure - State's Expenditure - KK- Schemes implemented in Town Panchayat under Infrastructure & Amenities Fund - 16-Major Works. (DPC 4515 00 800 KK 1601)

The expenditure sanctioned in para 4 above shall be met from the State Infrastructure and Amenities Fund by an adjustment only under the following Head of Account;-

"4515-00 CAPITAL OUTLAY ON OTHER RURAL DEVELOPMENT PROGRAMMES - 902 -Amount met from Infrastructure & Amenities Fund- JB Deduct- Amount met from State Infrastructure & Amenities Fund- Schemes implemented in Town Panchayat - 30 - Inter Accounts Transfer. (DPC 4515 00 902 JB 3004)

Per-contra Debit, the following Head of Accounts:-

J-Reserve Funds (b) Reserve Funds not bearing interest - 8229-00. Development and Welfare Funds-200. Other Development and Welfare Fund - AZ State Infrastructure & Amenities Fund (DPC 8229-00-200-AZ 0005) Outgo.

6. The Director of Town Panchayat is the Estimating, Reconciling and controlling authority for the above new head of account. The Pay and Accounts Officer / Treasury Officer concerned are directed to open the above new head of account in their books.

7. The expenditure sanctioned in para 4 above shall constitute an item of "New Service". The approval of the Legislature will be obtained in due course. Pending approval of the Legislature, the expenditure may be initially met by drawl of an advance from the contingency fund. The Director of Town Panchayat, Chennai-600 108 is directed to calculate the actual amount required for the period upto next supplementary estimates and apply for sanction of the same as advance from the Contingency fund to Finance (BG.I) Department directly in Form-A appended to the Tamil Nadu Contingency Fund Rules-1963 along with a copy of this order. Orders for sanction of advance from the Contingency Fund will be issued from Finance (BG.I) Department. He has also requested to send necessary explanatory notes for inclusion of the above expenditure in the Supplementary Estimates 2017-18 to Finance (BG.I/MAWS) Department at an appropriate time without fail.

8. The Director of Town Panchayat is also requested to furnish a copy of this Government Order along with the details of expenditure incurred / sanctioned under para 4 above to the Commissioner of Town and Country Planning for making necessary adjustments regarding the contra debit entries mentioned para 5 above through the Accountant General (A&E), Chennai at the end of the Financial Year 2017-18.
