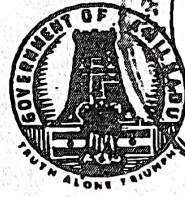

Tamil Nadu Slum Clearance Board - Release of Rs.3049.66 lakh as grant from Infrastructure and Amenities Fund towards Additional State share for construction of 6000 tenements at Ezhil Nagar Okkium Thoraipakkam under the Basic Services for the Urban Poor (BSUP) component of the Jawaharlal Nehru National Urban Renewal Mission (JnNURM) - Orders - Issued.

ORDER:

The Government vide the order first read above, has accorded administrative sanction for construction of 6000 tenements at a project cost of Rs.19810.60 lakh at Ezhil Nagar Okkium Thoraipakkam to resettle the slum families residing on objectionable locations in Chennai with funding assistance under the Basic Services for the Urban Poor (BSUP) component of the Jawaharlal Nehru National Urban Renewal Mission (JnNURM).

2. The Government vide the order second read above, has approved the revised project cost at Rs.22860.26 lakh and decided to bear the additional State share of Rs.30.50 crore for the said project of construction of 6000 tenements at Ezhil Nagar Okkium Thoraipakkam with the following funding pattern:-

3. The Director of Municipal Administration vide the reference third read above, has requested the Government to release the Additional State Share of Rs.30.50 crore for the said project under the Basic Services for the Urban Poor (BSUP) component of the Jawaharlal Nehru National Urban Renewal Mission (JnNURM).

4. Now, the Director of Town and Country Planning vide the reference fourth read above, has informed that the State Infrastructure and Amenities Promotion Committee through Circulation Note has sanctioned Rs.30.50 crore for construction of 6000 tenements at Ezhil Nagar Okkium Thoraipakkam as grant from the Infrastructure and Amenities Fund towards additional State share and has requested approval of the Government for the said sanction by the State Infrastructure and Amenities Promotion Committee.

5. The Government after careful examination, accept the proposal of the Director of Town and Country Planning / the Director of Municipal Administration and accord approval for the sanction of Rs.30,49,66,000/- (Rupees Thirty crore forty nine lakh sixty six thousand only) as grant from the Infrastructure and Amenities Fund made by the State Infrastructure and Amenities Promotion Committee towards additional State share for construction of tenements at Ezhil Nagar Okkium Thoraipakkam under the Basic Services for the Urban Poor (BSUP) component of the Jawaharlal Nehru National Urban Renewal Mission (JnNURM).

6. The amount sanctioned in para 5 above shall be debited to the following heads of account:-

General Component (74%) – Rs. 22,56,74,840/- (Rupees Twenty two crore fifty six lakh seventy four thousand eight hundred and forty only)

“2217-Urban Development -04-Slum Area Improvement-192. Assistance to Municipalities / Municipal Councils- II State Plan JC.Jawaharlal Nehru National Urban Renewal Mission (JNNURM) – Basic Services to Urban Poor -Controlled by Commissioner of Municipal Administration-09 Grants -in -Aid – 02 Grants for Creation of Capital Assets (DPC 2217-04-192 JC.0923)”.

Special Component (26%) Rs. 7,92,91,160/- (Rupees Seven crore ninety two lakh ninety one thousand one hundred and sixty only)

“2217 Urban Development -04-Slum Area Improvement -789 Special Component Plan for Schedule Castes – II State Plan JH. Jawaharlal Nehru National Urban Renewal Mission (JNNURM) – Basic Services to Urban Poor under Special Component Plan - Controlled by Commissioner of Municipal Administration-09. Grants in Aid – 02 Grants for Creation of Capital Assets (DPC 2217-04-789-JH-0928)”.

7. The expenditure sanctioned in para 5 above shall be adjusted to the following head of account:-

"2217 - Urban Development - 04. Slum Area Improvement-902- Deduct - Amount met from Infrastructure Development Fund- JB. Deduct- Amount met from State Infrastructure and Amenities Fund- Additional State Matching Share under JNNURM-BSUP Scheme-30. Inter Account Transfers (DPC 2217-04-902-JB-3005)".

8. The Commissioner of Municipal Administration is authorized to draw the amount sanctioned in para 5 above by means of an account payee cheque drawn in favour of "Commissioner of Municipal Administration's BSUP & IHSDP Savings Account No.50100062940381" maintained in the HDFC Bank, Chennai.

9. The Commissioner of Municipal Administration is requested to furnish a copy of this Government Order along with the details of expenditure incurred under para 5 above to the Director of Town and Country Planning for making necessary adjustments regarding the contra debit entries mentioned in para 6 through the Accountant General (A&E), Chennai at the close of Financial Year 2015-2016.
