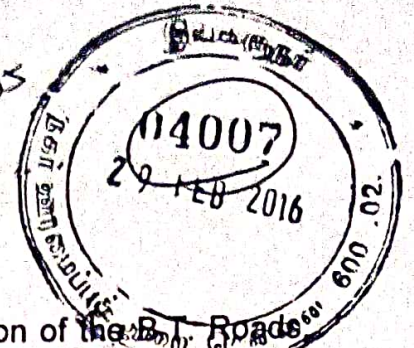

ORDER:

The Director of Town and Country Planning in his letter read above has stated that a proposal for construction of B.T.Roads, Concrete pavement and drainage for Avani Perur Keelmugam East Panchayat of Edappadi Panchayat Union in Salem District at a cost of Rs.321.38 Lakh under Infrastructure and Amenities fund has been received from the District Collector / Chairman, District Rural Development Agency, Salem and the same was placed in the 14th meeting of the State Infrastructure and Amenities Promotion Committee meeting held on 6.10.15 vide agenda No.12 and the Committee decided as follows:

"The Committee discussed in detail and decided to sanction Rs.321.38 lakhs from Infrastructure and Amenities fund for the project".

2. The Director of Town and Country Planning has therefore requested the Government to issue necessary Administrative Sanction and Fund release.

3. The Government after careful examination accepted the proposal of the Director of Town and Country Planning as recommended by Infrastructure and Amenities Promotion Committee and sanction is accorded for a sum of Rs.321.38 lakh for the construction of B.T. Roads, Concrete Pavement and drainage for Avani Perur Keelmugam East Panchayat of Edappadi Panchayat Union in Salem District under Infrastructure and Amenities fund.

4. The Director of Rural Development and Panchayat Raj is directed to make ensure that there is no over lapping / duplication with other construction works already in operations as ongoing schemes (Such as National Bank for Agriculture and Rural Development (NABARD), Pradhan Mandri Gram Sadak Yojana (PMGSY).

5. The expenditure sanctioned in para 3 above shall be debited to the following new head of account:-

7. Necessary additional funds will be provided in FMA / FSE 2015-2016. However, this expenditure shall be brought to the notice of the Legislature by specific Inclusion in the Supplementary Estimate 2015-16. Pending provision of such funds in FMA 2015-16, the Director of Rural Development and Panchayat Raj is authorized to incur the expenditure sanctioned in para 3 above.
