The Hon'ble Minister for Municipal Administration has made the following announcement during the Demand for Grants of Municipal Administration and Water Supply Department on the floor of the Tamil Nadu Legislative Assembly on 24.08.2021:-

2. The Principal Secretary / Commissioner, Greater Chennai Corporation has placed the proposal regarding construction of Modern Fish Market Loop Road in Division - 125, Zone-IX and other 4 schemes before the State Infrastructure and Amenities Promotion Committee.

3. The 18th State Infrastructure and Amenities Promotion Committee in its meeting held on 12.10.2021 has resolved to sanction Rs.10.75 crore from the Infrastructure and Amenities Fund to the GCC for taking up the construction of Modern Fish Market on Loop Road.

In the letter read above, the Principal Secretary / Commissioner, Greater Chennai Corporation has sent the Detailed Project Report and requested the Government to accord administrative sanction for construction of Modern Fish Market on Loop Road in Division-125, Zone-IX Greater Chennai Corporation at an estimated cost of Rs.9,97,00,000/- under Infrastructure and Amenities Fund.

The Government, after careful examination of the proposal of the Principal Secretary / Commissioner, Greater Chennai Corporation, accord administrative sanction for the construction of Modern Fish Market on Loop Road in Division - 125, Zone-IX GCC at an estimated cost of Rs.9,97,00,000 crore (Rupees Nine Crore and Ninety Seven Lakh Only) under Infrastructure and Amenities Fund.
