The State Infrastructure and Amenities Promotion Committee in its 13th Meeting dated 06.11.2014, among others, have recommended to execute the following works under Infrastructure and Amenities Fund:-

2. In the letter first read above, the Commissioner of Town and Country Planning has stated that based on the recommendation of Infrastructure and Amenities Promotion Committee, the District Collector, Thanjavur, has sent necessary proposals to the Commissioner of Town & Country Planning. The District Collector, Thanjavur, in his proposal has stated as follows:-

(i) Formation of Thiruvaiyaru Road with Culvert and bridges in corporation area at an estimated cost of Rs.1070.00 Lakhs:-

The Old Thiruvaiyar road is one of the oldest roads in the Thanjavur City Municipal Corporation. In the olden days, this road was used as a main road to Kumbakonam and Thiruvaiyar. Afterwards, this route was not used for heavy vehicular transport. At present, the Karanthai Rajaveethi road is being used for heavy vehicular traffic which is insufficient to handle the traffic. So the relaying of Old Thiruvaiyar road and bringing it for use is found necessary to regulate the heavy traffic in the city. The estimates for the above proposal have been prepared based on the current PWD and Highways schedule of rates for the year 2014-15 and the work will be carried out as per standard specifications.

(ii) Construction of 9 Bridges in the Moat area around the Thanjavur Big fort at an estimated cost of Rs.3455.00 Lakh:-

The District Collector has stated that with a view to improve the infrastructure facilities and aesthetics of the important heritage town-Thanjavur, it is proposed,

- a) To improve the condition of the moat which was created long ago around the palace and the four Rajaveedhis by removing bushes and desilting the moat. Thus, storage of water in the moat will be ensured which will improve the ground water table in the surrounding area. This work is under progress.
- b) To arrange for boating in the moat for the tourists.
- c) To create parks with tall trees on the banks of the moat with proper bridges across the moat will be of immense use to improve the aesthetics of the place and will be well used by the tourists.

Based on this, the following projects have been proposed under Infrastructure and Amenities Fund:-
