### **ORDER:**

In the G.O. first read above, the Government accorded administrative sanction to Salem Corporation for acquisition of land for formation of approach roads one at Oxford Bridge and the other at Gunpoint Bridge under phase-II of Thirumanimutharu and Vellakottai Channel Development Scheme and also sanctioned a sum of Rs.1.96 crore under Infrastructure and Amenities Fund.

2. In the letter third read above, the Commissioner, Salem Corporation has stated that the total extent of land required for the formation of approach road (6921 sq.ft near Oxford Bridge and 4187 Sq.ft. near Gunpoint Bridge) has taken possession, land acquisition process has been completed and registered. He has requested to release the amount of Rs.1.96 crore from Infrastructure and Amenities Fund for the formation of approach road at two bridges.

3. The Government, after careful examination of the proposal of Commissioner, Salem Corporation, releases a sum of Rs.1.96 crore (Rupees One crore and ninty six lakhs only) under Infrastructure and Amenities Fund for formation of approach road at Oxford Bridge and Gunpoint Bridge, Salem Corporation.

4. The amount sanctioned in para-3 above shall be debited into the following head of account:-

"4217. Capital Outlay on Urban Development - 60. Other Urban Development Schemes - 051. Construction - Schemes in Twelfth Five year plan -II. State Plan - . JR. Assistance for the construction works in Municipal Corporations from Infrastructure and Amenities Fund - 16. Major Works".

5. The above expenditure shall be adjusted by deducting under following head of account:-

"2217- Urban Development-05-Other Urban Development Schemes-902-Deduct-Amount met from Infrastructure Development Fund-JB, Amount met from State Infrastructure and Amenities Fund - 30. Inter Account Transfers (DPC:2217-05-902-JB-3004)

6. Necessary additional funds will be provided in Revised Estimates/ Final Modified Appropriation, 2013-2014. Pending provision of such funds, the Commissioner of Town and Country Planning is authorized to draw the amount sanctioned in para 3 above and disburse to Commissioner of Municipal Administration. The Commissioner of Municipal Administration is directed to send necessary proposals to Government in Finance (BG-1) Department, in the prescribed format along with a copy of this order, without fail.
