**ORDER:**

In the Government order first read above, revised Administrative Sanction was issued to the tune of Rs.320,54,00,000/- for the Dedicated Water Supply Scheme to Salem City Municipal Corporation as a grant from the Infrastructure and Amenities Fund.

2. In the reference second read above, the Commissioner, Salem Corporation has requested to release an additional amount of Rs.37.45 crore from Infrastructure and Amenities fund available with Director of Town and Country Planning.



3. The Government after careful examination release a sum of Rs.37.45 Crores (Thirty Seven crore forty five lakhs only) from the State Infrastructure and Amenities Fund for the Dedicated Water Supply Scheme to Salem City Municipal Corporation.

4. The amount sanctioned in para 3 shall be debited to the following new head of account: to be opened under Demand No: 34.02

7. The concerned Pay and Accounts Officer / Treasury Officer's are requested to open the above mentioned new heads in their books.

8. The item of expenditure is treated as "**New Service**". The approval of the Legislature will be obtained in due course. Pending approval of the Legislature, the expenditure will be initially met by sanction of an advance from the Contingency Fund, orders regarding which the Government in Finance (BG-I) Department will issue separately. The Commissioner of Municipal Administration



is authorized to draw and disburse the amount sanctioned in para 3 above. The Commissioner of Municipal Administration is directed to send necessary proposals to Government in Finance (BG-I) Department, in the prescribed format along with a copy of this order for sanction of an advance required for the current year from Contingency Fund, without fail.

9. The Accountant General, Chennai – 18 is requested to make necessary adjustments at the end of the financial year 2013-2014.
