During the Budget session 2014-2015, while moving Demand

local planning area. Master plan will be prepared for these
to ensure planned development."

2. Based on the above announcement, the Commissioner of Town
and Country Planning, in his letter read above has requested the
Government to declare the area covered under Vedaranyam Municipality
the local planning area of Vedaranyam under clause (b) of sub-
section (1) of section 10 of the Tamil Nadu Town and Country Planning
Act, 1971 (Tamil Nadu Act 35 of 1972), on the basis of resolution No.821,
dated 25.01.2011 of Vedaranyam Municipality and Administrative Report
2013-2014 of Vedaranyam Municipality.

3. The Government, after careful consideration have decided to
accept the proposal of the Commissioner of Town and Country Planning in
para 2 above and declare their intention to specify the area comprising in
Second Grade Municipality of Vedaranyam to be a local planning area
under clause (b) of sub-section (1) of section 10 of the said Act.

4. Accordingly, the appended Notification will be published in
English in the Tamil Nadu Government Gazette.

5. The Collector of Nagapattinam District is requested to republish
the Notification, both in English and Tamil in the District Gazette.
