ORDER:

In the letter first read above, the Director of Town and Country Planning has stated that the Commissioner of Municipal Administration has sent a proposal for seeking fund amounting to Rs.21.01 crore (Rupees Twenty one crore and one lakh only) under Infrastructure and Amenities fund for improvement of works such as laying of road, storm water drain, culverts, street lights, etc, in five Municipalities viz., Theni Allinagaram, Chinnamanur, Cumbum, Periyakulam and Gudalur of Theni District.

2. The Director of Town and Country Planning has also stated that an additional fund of Rs. 21.01 crore (Rupees Twenty one crore and one lakh only) as requested by the Commissioner of Municipal Administration has been approved by State Infrastructure and Amenities Promotion Committee.

3. The Director, Town and Country Planning has requested the Government to issue Administrative sanction of 21.01 crore (Rupees Twenty one crore and one lakh only) for the above works and also to release the fund.

4. The Government after careful examination on the proposal of the Director of Town and Country Planning and decided to accord administrative sanction for works such as improvement of Roads, Storm Water drains, culverts, street lights etc., in Theni Allinagaram, Chinnamanur, Cumbum, Periyakulam and Gudalur Municipalities of Theni District and also to release additional fund of Rs.21.01 Crore

(Rupees Twenty one crore and one lakh only) from the Infrastructure and Amenities fund. Municipalitywise abstract details of works and Estimated cost is annexed to this order.

5. The amount sanctioned in para 4 above shall be debited into the following head of account:-

"2217.Urban Development - 05. Other Urban Development Schemes - 800. Other Expenditure - State's Expenditure - KA. Schemes implemented in Urban Local Bodies under Infrastructure and Amenities Fund - 309. Grants in Aid-02. Grants for creation of Capital Assets".

6. The expenditure sanctioned in para - 4 above shall constitute an item of "new Instrument of Service" and the approval of the Legislature will be obtained in due course. Pending approval of the Legislature, the expenditure may be initially met by drawl of an advance from the Contingency Fund. The Commissioner of Municipal Administration is directed to calculate the actual amount required for the period upto next supplementary Estimates and apply for sanction of the same as advance from the contingency Fund to Finance (BG-I) Department directly in Form 'A' appended to the Tamil Nadu Contingency Fund Rules 1963 along with copy of this order. Order for sanction of an advance from the Contingency Fund will be issued from Finance (BG-I) Department. The Director of Town and Country Planning is also directed to send necessary draft explanatory notes to include the above expenditure in the Supplementary Estimates for the year 2020-2021 to Government in Finance (BG-I/MAWS) Department at the appropriate time without fail.

7. The Commissioner of Municipal Administration shall furnish a copy of the Government Order along with the details of expenditure incurred out of the above funds sanctioned in para 4 above to the Director of Town and Country Planning and the Accountant General (A&E), Chennai for making necessary adjustment entries mentioned in para 5 at the end of Financial Year 2020-21.

8. This order issues with the concurrence of Finance (MAWS) Department vide its U.O.No.50485/Fin(MAWS)/2020, dated 04.01.2021 and ASL.No.1347 (one thousand three hundred and forty seven) and Housing and Urban Development Department U.O.No.173/UD4(1)/2021-1, dated 06.01.2021.
