ORDER:

The Hon'ble Minister (Finance and Human Resources Management) has made the following announcement in the Revised Budget 2021-2022:-

"An integrated bus stand cum commercial centre will be established in Tiruchirappalli with the financial assistance of Tamil Nadu Urban Finance and Infrastructure Development Corporation (TUFIDCO)".

2. Accordingly, in the Government Order first read above, Government have accorded administrative sanction for construction of Integrated Bus Terminal and other infrastructure facilities at Panjappur in Tiruchirappalli Municipal Corporation at an estimated cost of

Rs.349.98 crore with the following funding pattern:

In the Government order second, third and fourth read above, Government have released Rs.14.00 crore, Rs.32.20 crore and Rs.46.20 crore, respectively, as mobilization advance out of Infrastructure and Amenities Fund of Rs.140.00 crore for establishment of Integrated Bus Terminal and other Infrastructure facilities at Panjappur in Tiruchirappalli Municipal Corporation.

4. In the letter fifth read above, the Director of Municipal Administration has furnished the amount sanctioned and utilized under Infrastructure and Amenities Fund for establishment of Integrated Bus Terminal and other Infrastructure facilities at Panjappur in Tiruchirappalli Corporation, as detailed below :

The Director of Municipal Administration has requested to sanction and release the third and final quarter amount of Rs.47.60 crore (34%) under Infrastructure and Amenities Fund to pay bills for the completed work since, the work is under progress and so far an amount of Rs.46.20 crore (33%) each as first and second instalment have been released and completely utilized.

6. The Government after careful examination have decided to accord sanction and release a sum of Rs.26,00,00,000/- (Rupees twenty six crore only) under Infrastructure and Amenities Fund for establishment of Integrated Bus Terminal and other Infrastructure facilities at Panjappur in Tiruchirappalli Corporation.

7. The amount sanctioned in Para 6 above shall be debited to the following head of account:-

"2217 - Urban Development - 05 - Other Urban Development Schemes - 800 - Other Expenditure - State's Expenditure - KA - Schemes implemented in Urban Local Bodies under Infrastructure and Amenities Fund - 309 - Grants-in-Aid - 02 - Grants for creation of Capital Assets".

The expenditure sanctioned in para 6 above shall be met from the State Infrastructure and Amenities Fund by adjusting under the following head of account:-
