ORDER:

In the Government order first read above, the Government have accorded administrative sanction for an amount of Rs.12.50 crore under Tamil Nadu Town and Country Planning Development Fund for Phase II Programme towards preparation of Master Plan for 14 composite local planning areas, 16 declared composite local planning areas and 17 newly constituted single local planning areas and regional plan for 3 regional areas.

2. In the Government order second read above, the Government have accorded administrative sanction for a sum of Rs.9,79,87,500/- for preparation of Regional Plans for Coimbatore and Madurai covering at an extent of 18,244 Sq.Km and 20,951 Sq.Km. respectively.

3. In the letter 3rd read above, the Director of Town and Country Planning has stated that the regional plan for Tirunelveli region shall be taken up with Asian Development Bank funding under CKIC (Chennai – Kanniyakumari Industrial Corridor). The preparation of Madurai region is funded by the Asian Development Bank and action has been taken to identify and engage the consultant as per the norms of the ADB. The School of Planning and Architecture, Bhopal is the consultant identified for preparation of regional plans for Coimbatore and Nilgiris regions.

4. In the Government order fourth read above, the Government have notified 12 Regional Planning Areas under section 10(5) of Tamil Nadu Town and Country Planning Act, 1971 as below:-

The Director of Town and Country Planning has further stated that out of the above 12 Regional Planning Areas, the preparation of regional plans for Coimbatore Region, Nilgiris Region and Madurai region are under progress. For Chennai Metropolitan Area, Chennai Metropolitan Development Authority is taking separate action for preparation of plans. Hence, it has been planned to take up remaining 8 Regions out of 12 for the preparation of Regional Plans. He has also furnished the details of the fund position and
