**ORDER:**

In the Government Order first read above, the Government notified its intention to declare the local area comprising in Sholinghur Municipality to be a Sholinghur local planning area under clause (b) of sub-section (1) of section 10 of the Tamil Nadu Town and Country Planning Act, 1971 (Tamil Nadu Act 35 of 1972) and the same was published in the Housing and Urban Development Department's Notification No.II(2)/HOU/843/2021 at page 488 of Part II - Section 2 of the Tamil Nadu Government Gazette, dated the 8<sup>th</sup> December 2021 and also in the Ranipettai District Gazette, dated the 22<sup>nd</sup> January 2022 for general information as required under clause (b) of sub-section (1) of section 10 of the said Act.

2. In the letter second read above, the Director of Town and Country Planning has stated that no objections and suggestions were received from the public in this matter and he has requested to declare the Sholinghur Local Planning Area under sub-section (4) of section 10 of the said Act.

3. The Government after careful examination, have decided to accept the proposal of the Director of Town and Country Planning in para 2 above. Accordingly, the Government declares that the areas specified in the Notification appended to this order, to be the Sholinghur Local Planning Area under sub-section (4) of section 10 of the Tamil Nadu Town and Country Planning Act, 1971 (Tamil Nadu Act 35 of 1972).

4. The appended Notification will be published in the next issue of Tamil Nadu Government Gazette.
