ORDER:

The Director of Town and Country Planning in his letter third read above, has requested the Government to include surrounding villages in Udumalpet Local Planning Area under section 10(1) (b) of the Town and Country Planning Act, 1971 (Tamil Nadu Act 35 of 1972) since the area nearby Udumalpet is developing in a fast manner.

2. The Government after careful examination of the proposal of Director of Town and Country Planning in para 1 above have decided to declare the intention of the Government to include additional areas in the Udumalpet Local Planning Area. The appended notification will be published in the Tamil Nadu Government Gazette.

3. The Collector of Tiruppur District is directed to republish the notification in the District Gazette.

4. The Director of Translation, Chennai -9 is directed to arrange to have the Notification, translated into Tamil and to forward the translation urgently to the Collector of Tiruppur District under intimation to the Government.

5. The Collector of Tiruppur District is directed to report to Government, the date of republication of notification in the District Gazette.

NOTIFICATION.

In exercise of the powers conferred by clause (b) of sub - section (1) of section 10 of the Tamil Nadu Town and Country Planning Act, 1971 (Tamil Nadu Act 35 of 1972), the Governor of Tamil Nadu hereby declares his intention to include additional areas in the Udumalaipettai local planning area and to make the following amendment to the Rural Development and Local Administration Department Notification No.II/(2)/RUL/2022/74, published at page 209 of Part II - Section 2 of the Tamil Nadu Government Gazette, dated the 10th April 1974.

2. 
