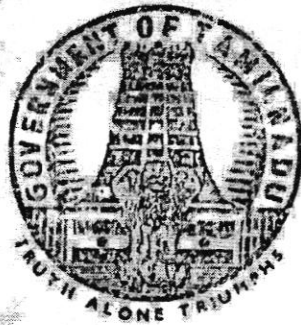

No. 11 (2)/IND/1469/79.-The following notification of the Ministry of Steel and Mines of the Government of India published in the Gazette of India (Extraordinary Part II) Section 3 (i) as G.S.R. 2 (E), dated 1st January 1979, is republished:-

In exercise of the powers conferred by sub-section (1) of section 9 of the Mines and Minerals (Regulation and Development) Act, 1957 (67 of 1957), the Central Government makes the following further amendments in the Second Schedule to the said Act, namely:-

In the Second Schedule to the aforesaid Act, for the entries relating thereto, the following shall be substituted, namely:-

"B. Manganese Ore-

(a) Manganese dioxide (containing 78 per cent or more of MnO2 and 4 per cent or below Fe.

(b) 46 per cent Mn and above .. Twelve rupees per tonne

(c) 35 per cent Mn and above but below 46 per cent Mn. .. Seven rupees and paise per tonne

(d) Below 35 per cent Mn but 25 per cent Mn. .. Five rupees per tonne

(e) 25 per cent Mn or below .. Two rupees per tonne

2. This notification shall come into force on and with effect from 1st January 1979.

Reduction of tax payable by public carrier goods vehicles having National Permits under Tamil Nadu Motor Vehicles Taxation Act.
(G.O. Ms. No. 2047, Home, 2nd August 1980.)
No. II (2)/HO/3858/80.—In exercise of the powers conferred by section 20 of the Tamil Nadu Motor Vehicles Taxation Act, 1974 (Tamil Nadu Act 13 of 1974) and in pursuance of the Home Department Notification Nos. II (2)/HO/4028 and 4029/75, dated the 30th October 1975, published at page 602 in Part II—Section (2) of the Tamil Nadu Government Gazette dated the 19th November 1975, the Governor of Tamil Nadu hereby reduces the tax payable under the said Act in respect of any public carrier goods vehicles registered in a State other than the State of Tamil Nadu and authorised to ply in the State of Tamil Nadu, under a permit granted by the appropriate authority of the State in which a National permit is issued in pursuance of sub-section (1) of section 63 of the Motor Vehicles Act, 1939 (Central Act IV of 1939) to Rs 1,000—(rupees one thousand only) per annum per vehicle irrespective of the leaden weight of the vehicle.

The tax aforesaid shall be paid on or before the 15th March of every year or in two equal instalments, the first instalment before the 15th March of every year for the period April to September and the second instalment before the 15th September (of current financial year) for the period October to March.
Where the authorisation in respect of the National Permit is granted at any time after the first quarter of the financial year the tax shall be assessed on prorata basis for the remaining quarters of the financial year including the quarter in which such authorisation is granted.

The Tamil Nadu Town and Country Planning Act 1971 (Tamil Act 35 of 1972) provides for the constitution of Regional Planning Authority, Local Planning Authority and the New Town Development Authority after the declaration of Regional Planning Area, Local Planning Area or a site for a New Town. In this case may be, under section 10 of the said Act. According to section 11 (3) of the Tamil Nadu Town and Country Planning Act, 1971 the Local Planning Authority constituted under section 11 (1) of the Act shall consist of:-

- a) The Chairman to be appointed by the Government
- b) The representatives of Local Authorities as specified below:-

(i) In case where there is only one Local Authority functioning in a Local Planning Area such local authority has been declared as the Local Planning Authority two representatives nominated by the Local Authority and the Chief Executive Officer of that Local Authority.

(ii) In other case, where there are two or more local authorities functioning in a local planning area such persons not exceeding four in number who are members of the local authorities functioning in the whole or part of the area appointed by the Government.
