ORDER:

Gummidipoondi Local Planning Area was notified and declared under clauses (1) and (4) of section 10 of Tamil Nadu Town and Country Planning Act, 1971 (Tamil Nadu Act 35 of 1972) in the Government orders first and second read above respectively.

2. During the Budget session 2016-17, while moving Demand No.26, the Minister (Housing and Urban Development) made the following announcement on the floor of Assembly:-

"Annexing the villages and expanding the boundaries, the Gummidipoondi Local Planning Area shall be declared as Composite Local Planning Authorities".

3. Based on the above announcement, the Commissioner of Town and Country Planning (i/c) has sent the proposal for expansion of the Gummidipoondi local planning area by inclusion of additional areas under clause (b) of sub-section (1) of section 10 of the said Act, as Gummidipoondi Composite Local Planning Area.

4. The Government, after careful consideration of the above proposal of the Commissioner of Town and Country Planning have decided to declare the intention of the Government to include additional areas in the Gummidipoondi local planning area as Gummidipoondi composite local planning area under clause (b) of sub-section (1) of section 10 of the said Act. The appended Notification will be published in the Tamil Nadu Government Gazette.

5. The Collector of Thiruvallur District is directed to republish the Notification in the District Gazette.

6. The Director of Translation, Chennai-9, is directed to arrange to have the Notification translated into Tamil and to forward the translation urgently to the Collector of Thiruvallur District under intimation to the Government.

7. The Collector of Thiruvallur District is directed to report to the Government, the date of republication of the Notification in the District Gazette.



NOTIFICATION.

In exercise of the powers conferred by clause (b) of sub-section (1) of section 10 of the Tamil Nadu Town and Country Planning Act, 1971 (Tamil Nadu Act 35 of 1972), the Governor of Tamil Nadu hereby declares his intention to include additional areas in the Gummidipoondi local planning area and to make the following amendment to the Housing and Urban Development Department Notification No.II(2)/HOU/1573/80, published at page 247 of Part II-Section 2 of the Tamil Nadu Government Gazette, dated the 16th April 1980.
