In the references read above, the Industries Department has forwarded the Business Reforms Action Plan - 2019. The Government of India has made the implementation of 'Ease of Doing Business' for the Industrial applications received through 'Single Window' mandatory. The Guidance Bureau is coordinating and implementing the system. There are certain reforms suggested by the Department of Industrial Policy and Promotion (DIPP) in the reference above cited.

Reform Point No.30 in 'Ease of doing business' relates to site inspection wherein it is stated 'Publish Well Defined Inspection Procedure and Checklist' on the Website and 'Mandate that the inspection shall be limited to the Checklist' Reform Point No.32 Mandates that 'Online Submission of Inspection Report' is to be uploaded within 48 hours in the department.

Henceforth, it is hereby ordered that for all the Planning Permission Applications received in Directorate of Town and Country Planning, the Inspection Report shall be limited to the Checklist published and also the Inspection Report shall be uploaded online within 48 hours after completing the inspection.

This order takes immediate effect.
