ORDER:

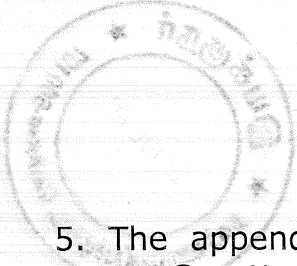

2. In the Government Order second read above, orders were issued to accord administrative sanction for preparation of Master Plan for 75 towns.

3. In the letter third read above, the Director of Town and Country Planning has requested the Government to add certain additional areas in the said Vandavasi local planning area under clause (b) of sub-section (1) of section 10 of the said Act.

The Government, after careful consideration of the above proposal of the Director of Town and Country Planning have decided to declare their intention to specify the areas mentioned in the Notification appended to this Order as Vandavasi Local Planning Area under clause (b) of sub-section (1) of section 10 of the said Act.

APPENDIX.
NOTIFICATION.

In exercise of the powers conferred by clause (b) of sub-section (1) of section 10 of the Tamil Nadu Town and Country Planning Act, 1971 (Tamil Nadu Act 35 of 1972), the Governor of Tamil Nadu hereby declares his intention to add the areas of the following revenue villages to the Vandavasi Local Planning Area comprising Vandavasi Municipality, which has been declared as such vide the Housing and Urban Development Department's Notification No.II(2)/HOU/732/2004, published at page 402 of Part II-Section 2 of the Tamil Nadu Government Gazette, dated the 18th August 2004, namely:-

2. Any inhabitant or any local authority or institution in the above said areas, may submit any objection or suggestion, in writing, on the proposed addition, to the Government within two months from the date of the publication of this Notification in the Tamil Nadu Government Gazette. The objections or suggestions, if any, which may be received within the said period, will be taken into consideration before pursuing further action in terms of sub-section (4) of section 10 of the said Act.
