ORDER:

The delay of 1206 days in the preparation of Master Plan and convening a meeting of the Local Planning Authority is hereby condoned. Copies of the Master Plan for Srivilliputhur Local Planning Area as approved by Government are communicated to the Director of Town and Country Planning.
