### **ORDER:**

In the Government order first read above, the Tirupattur Local Planning Area was declared under sub-section (4) of section 10 of the Tamil Nadu Town and Country Planning Act, 1971 (Tamil Nadu Act 35 of 1972).

In the Government order second read above, the Government notified its intention to include additional areas in the said Tirupattur Local Planning Area and the same was published in Housing and Urban Development Department's Notification No.II(2)/HOU/483/2020 at page 600 of Part II - Section 2 of the Tamil Nadu Government Gazette, dated the 5<sup>th</sup> August 2020 and also in the Tirupattur District Gazette, dated the 25<sup>th</sup> September 2021 for general information as required under clause (b) of sub-section (1) of section 10 of the said Act.

3. In the letter third read above, the Director of Town and Country Planning has stated that no objections and suggestions were received from the public in this matter and he has requested for confirmation of Notification for Tirupattur Local Planning Area under sub-section (4) of section 10 of the said Act.

4. The Government after careful examination of the proposal of the Director of Town and Country Planning in para 3 above have decided to accept the same. Accordingly, the Government declare that the areas specified in the Notification appended to this order to be Tirupattur Local Planning Area.

5. The appended Notification will be published in the next issue of Tamil Nadu Government Gazette.

6. The Collector of Tirupattur District is directed to republish the Notification in the District Gazette.

7. The Director of Translation, Chennai-09 is directed to arrange to have the Notification translated into Tamil and to forward the translation urgently to the Works Manager, Government Central Press for publication of the same in the Tamil Nadu Government Gazette and also to the Collector of Tirupattur District under intimation to the Government.

8. The Collector of Tirupattur District is directed to report to Government the date of republication of the notification in the District Gazette.
