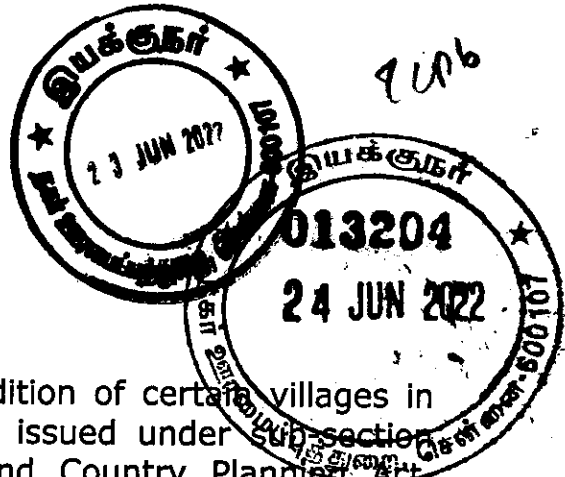

ORDER:

In the Government Order first read above, the Thoothukudi local planning area was declared under sub-section (4) of section 10 of the Tamil Nadu Town and Country Planning Act, 1971 (Tamil Nadu Act 35 of 1972).

2. In the Government Order second read above, the Government declared its intention to include additional areas in the said Thoothukudi local planning area and the same was published in Housing and Urban Development Department's Notification No.II(2)/HOU/467/2013 at page 463 of Part II - Section 2 of the Tamil Nadu Government Gazette, dated the 10th July 2013 and also in the Thoothukudi District Gazette, dated the 6th October 2021 for general information as required under clause (b) of sub-section (1) of section 10 of the said Act.

3. In the letter third read above, the Director of Town and Country Planning has stated that no objections and suggestions were received from the public in this matter and he has requested for confirmation of Notification for Thoothukudi local planning area under sub-section (4) of section 10 of the said Act.

4. The Government after careful examination of the proposal of the Director of Town and Country Planning in para 3 above have decided to

accept the same. Accordingly, the Government declares that the areas specified in the Notification appended to this order be included to the Thoothukudi Local Planning Area.

5. The appended Notification will be published in the Tamil Nadu Government Gazette.

6. The Collector of Thoothukudi District is directed to republish the Notification in the District Gazette.

7. The Director of Translation, Chennai-600009 is directed to arrange to have the Notification translated into Tamil and to forward the translation urgently to the Collector of Thoothukudi District under intimation to the Government.

8. The Collector of Thoothukudi District is directed to report to the Government the date of republication of the notification in the District Gazette.
