In exercise of the powers conferred by clause (b) of sub-section (1) of section 10 of the Tamil Nadu Town and Country Planning Act, 1971 (Tamil Nadu Act 35 of 1972), the Governor of Tamil Nadu hereby declares his intention to include additional areas in the Karaikudi local planning area and to make the following amendment to the Rural Development and Local Administration Department Notification No.II(2)/RUL/5046/74, published at page No.594 of Part II - Section 2 of the Tamil Nadu Government Gazette, dated the 27th November 1974.
