3. In the letter third read above, the Director of Town and Country Planning has requested the Government to add the additional areas in the said Nellikuppam local planning area clause (b) of sub-section (1) of section 10 of the said Act.

The Government, after careful consideration of the above proposal of the Director of Town and Country Planning have decided to declare their intention to specify the areas mentioned in the notification appended to the order as Nellikuppam local planning area under clause (b) of sub-section (1) of section 10 of the said Act.

### NOTIFICATION.

In exercise of the powers conferred by clause (b) of sub-section (1) of section 10 of the Tamil Nadu Town and Country Planning Act, 1971 (Tamil Nadu Act 35 of 1972), the Governor of Tamil Nadu hereby declares his intention to include the areas of the following revenue villages to the Nellikuppam Local Planning Area, which has been declared as a local planning area vide Rural Development and Local Administration Department Notification No.II(2)/RUL/2003/1974, published at page 208 of Part II-Section 2 of the Tamil Nadu Government Gazette, dated the 10<sup>th</sup> April 1974, namely:-
