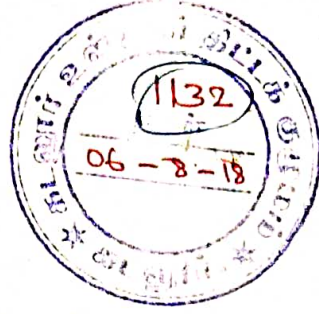

In the Government order second read above, the Government notified its intention to include additional areas covered under the Cuddalore Local Planning Area and the same was published in notification No.II(2)/HOU/414/2017 at pages 461-463 of Part-II Section 2 of the Tamil Nadu Government Gazette, dated the 24th May 2017 and also in the Cuddalore District Gazette, dated the 28th January, 2018 for general information as required under clause (b) of sub-section (1) of section 10 of the Tamil Nadu Town and Country Planning Act, 1971 (Tamil Nadu Act 35 of 1972).
