APPENDIX

NOTIFICATION.

In exercise of the powers conferred by sub-section(4) of section 32 and section 122 of the Tamil Nadu Town and Country Planning Act, 1971 (Tamil Nadu Act 35 of 1972), section 242 of the Tamil Nadu Panchayats Act, 1994 (Tamil Nadu Act 21 of 1994) and sub-section (1) of section 198 of the Tamil Nadu Urban Local Bodies Act, 1998 (Tamil Nadu Act 9 of 1999), the Governor of Tamil Nadu hereby makes the following amendments to the Tamil Nadu Combined Development and Building Rules, 2019:-

AMENDMENT.

In the said Rules.-

- (1) in rule 30, in sub-rule (5), after clause (ii), the following clause (iii) shall be added, namely:-
 - " (iii) In case of Mass Rapid Transit System Corridors and Suburban Rail Corridors as specified in Annexure-XXIV, for the properties located within a distance of five hundred metres measured from the centre line of the corridor, Premium FSI shall be charged at fifty per cent of the applicable premium FSI charges."; and
- (2) After Annexure –XXIII, the following Annexure shall be added, namely:-
