ORDER

The Hon'ble Chief Minister has made an announcement under Rule 110 in the Tamil Nadu Legislative Assembly as follows:-

"As a measure to promote green energy and environmental sustainability without compromising on energy security and developmental needs, harnessing of grid connected solar energy will be made mandatory for all buildings falling in the category of Group Development and Multi Storied Building by making necessary provision in Development Control Regulations".

2. Based on the above said announcement, the Member-Secretary, Chennai Metropolitan Development Authority and the Director of Town and Country Planning in their letter 19th and 20th read above, have sent proposals to the Government. In their letters, they have stated that maximum terrace area of a building to be reserved for erecting solar panel should be 1/3 of the total terrace area. They have further stated that for generating 1 KWH of electricity, space required to erect solar photo voltaic panels will be 10 Sq.m. Further, installation of Solar Energy System, has to be made mandatory in all buildings in the category of Special Buildings, Group Developments and Multi-Storeyed Buildings thereby amending

Development Regulations to the Second Master Plan for Chennai Metropolitan Area, 2026 and the Development Control Regulations in the master plans to the Local Planning areas of Coimbatore, Madurai, Vellore, Tiruvallur, Kancheepuram, Salem, Chengalpattu,, Tirupur, Tiruchirappalli, Erode and Gummidipoondi.

3. The Government after careful examination of the above said proposals, order as follows:-

Installation of Solar Energy System is hereby made mandatory in all buildings in the category of Special Buildings, Group Developments and Multi-Storeyed Buildings under the jurisdiction of Chennai Metropolitan Development Authority and Director of Town and Country Planning prospectively. Accordingly,

(i) Minimum terrace area to be reserved for erecting solar photo voltaic panels will be $1/3^{\text{rd}}$ of total terrace area.

(ii) The approximate space required for erecting solar photo voltaic panels is 10 sq.m. for generating 1 KW of electricity.

(iii) The electricity generated from solar photo voltaic system so erected will be used for common electricity requirements in the multi-ownership buildings like staircase lights, setback lights, lifts, pumps and non-floor space index areas, etc. However, in case of single ownership buildings, the electricity generated from solar photo voltaic system shall be used for all purposes.

(iv) Net metering guidelines of Tamil Nadu Energy Regulatory Commission shall apply to all such installation of solar photo voltaic system.

(v) The Chennai Metropolitan Development Authority and the concerned local planning authorities for the local planning areas shall monitor the actual erection and give completion certificate to the said buildings only after the erection of solar photo voltaic panels. The Tamil Nadu Generation and Distribution Corporation Limited will give service connection of net metering only after such completion certificate is obtained.

4. Accordingly, the Government hereby issue necessary variation to the Development Regulations in the Second Master Plan for the Chennai Metropolitan Area 2026 and also make variations to the Development Control Regulations for the Local Planning Areas of Erode, Vellore, Tiruvallur, Coimbatore, Madurai, Gummidipoondi, Kancheepuram, Salem, Chengalpattu, Tirupur, Tiruchirappalli and Mamallapuram approved in the Government orders 2nd, 4th, 5th, 7th to 10th, 12th to 15th and 18th read above respectively

under sub-section (4) of section 32 of the Tamil Nadu Town and Country Planning Act, 1971 (Tamil Nadu Act 35 of 1972).

5. The above Regulation shall also be followed in the Local Planning Areas of Tirunelveli and Thoothukudi. The above regulation shall form a part of Master Plan to be approved for the above said Local Planning Areas.

6. The Works Manager, Government Central Press, Chennai-600079 is directed to publish the Notification appended to this order in the next issue of the Tamil Nadu Government Gazette.

7. The Director of Town and Country Planning and the Member-Secretary, Chennai Metropolitan Development Authority are directed to pursue action accordingly.




