No. II(2)/HOU/574/2006.—In exercise of the powers conferred by sub-section (4) of Section 32 of the Tamil Nadu Town and Country Planning Act, 1971 (Tamil Nadu Act 35 of 1972), the Governor of Tamil Nadu hereby makes the following Variations to the Master Plan for the Manapparai Local Planning Area approved under the said Act, and published with the Housing and Urban Development Department Notification No. II(2)/HOU/1480/1993, dated the 9th February 1993, at pages 330-331 of Part II—Section 2 of the *Tamil Nadu Government Gazette*, dated the 24th March 1993:—

Exemption to Tamil Nadu State Palmgur and Fibre Marketing Co-operative Federation Limited, Kumarappapuram Branch, Chennai for certain period.

No. II(2)/LE/575/2006.—In exercise of the powers conferred by Section 87 read with Section 91-A of the Employees' State Insurance Act, 1948 (Central Act XXXIV of 1948), the Governor of Tamil Nadu hereby exempts the Tamil Nadu State Palmgur and Fibre Marketing Co-operative Federation Limited, Kumarappapuram Branch, Chennai from the provisions of the said Act for the period from 1st April 2004 to 31st March 2005.

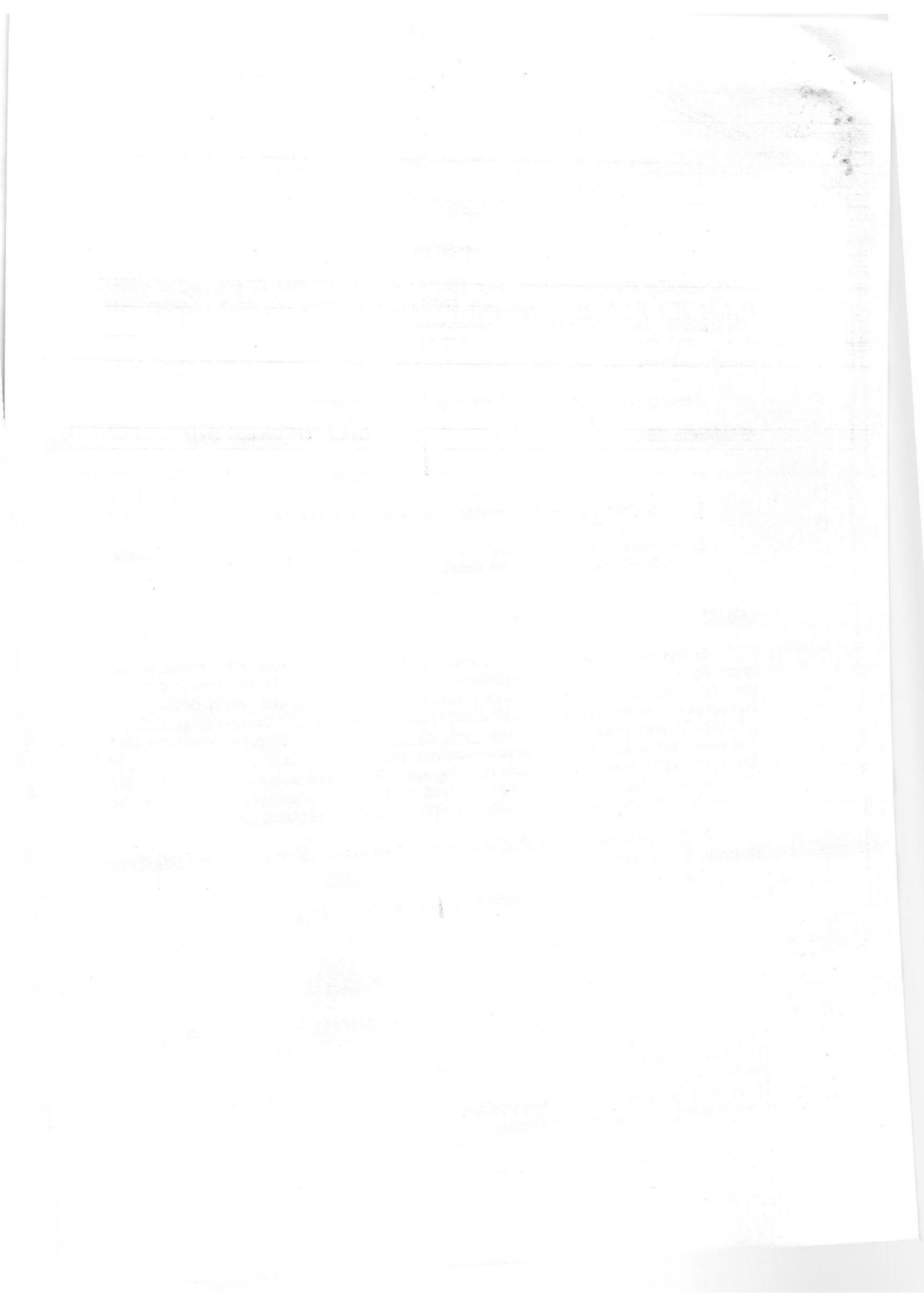

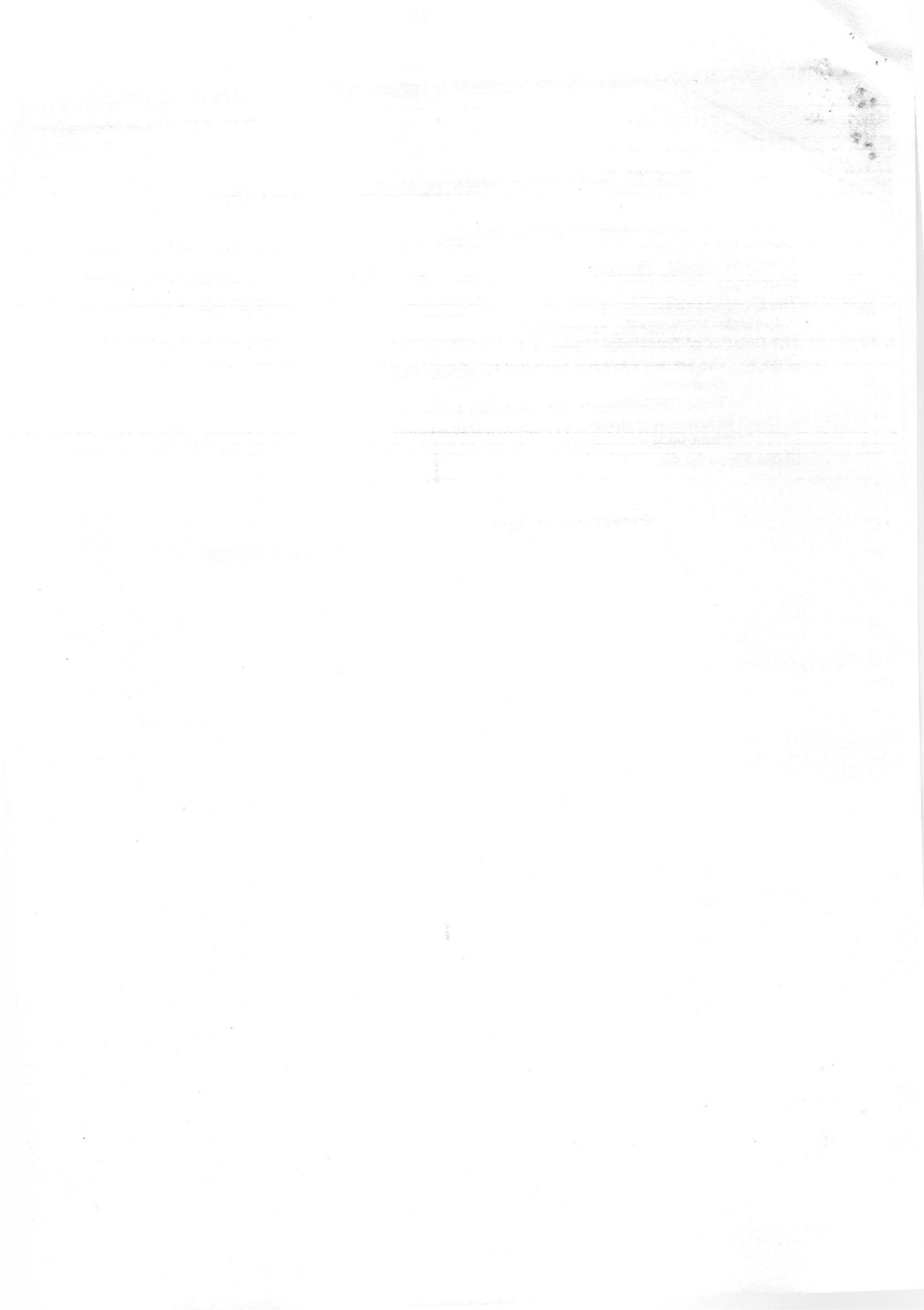
