### **ORDER:**

In the Government order first read above, the Government have notified 12 Regional Planning Areas under section 10(5) of Tamil Nadu Town and Country Planning Act, 1971 (Inclusive of Chennai Metropolitan Regional Planning Area).

2. In the letter second read above, the Director of Town and Country Planning has sent a proposal to the Government to constitute a Regional Planning Area of the Nilgiris District and to appoint members for the said authority under sub-section (2) of section 11 of the Tamil Nadu Town and Country Planning Act, 1971 (Tamil Nadu Act 35 of 1972).

3. The Government, after careful consideration of the proposal of Director of Town and Country Planning have decided to accept the same.

4. Accordingly, in exercise of the powers conferred by sub-section (2) of section 11 of the Tamil Nadu Town and Country Planning Act, 1971 (Tamil Nadu Act 35 of 1972), the Governor of Tamil Nadu, in consultation with the Director hereby constitutes the Regional Planning authority for Regional Planning Area of the Nilgiris District consisting of the following persons:-

- (a) The Director of Town and Country Planning as the Chairman;

- (b) The Deputy Director of Town and Country Planning of the region;
