In the Government Order first read above, Koothanallur Local Planning Area was declared under sub-section (4) of section 10 of the Tamil Nadu Town and Country Planning Act, 1971 (Tamil Nadu Act 35 of 1972).

2. In the Government Order second read above, orders were issued to accord administrative sanction for preparation of Master Plan for 75 towns.

3. In the letter third read above, the Director of Town and Country Planning has requested the Government to add certain additional areas in the said Koothanallur local planning area under clause (b) of sub-section (1) of section 10 of the said Act.

The Government, after careful consideration of the above proposal of the Director of Town and Country Planning have decided to declare their intention to specify the areas mentioned in the Notification appended to this Order as Koothanallur Local Planning Area under clause (b) of sub-section (1) of section 10 of the said Act.

5. The appended Notification will be published in the Tamil Nadu Government Gazette.

NOTIFICATION.

In exercise of the powers conferred by clause (b) of sub-section (1) of section 10 of the Tamil Nadu Town and Country Planning Act, 1971 (Tamil Nadu Act 35 of 1972), the Governor of Tamil Nadu hereby declares his intention to add the areas of the following revenue villages to the Koothanallur Local Planning Area comprising Koothanallur Municipality, which has been declared as such vide the Housing and Urban Development Department's Notification No.II(2)/HOU/30/2000 published at page 6 of Part II-Section 2 of the Tamil Nadu Government Gazette, dated the 12th January 2000, namely:-
