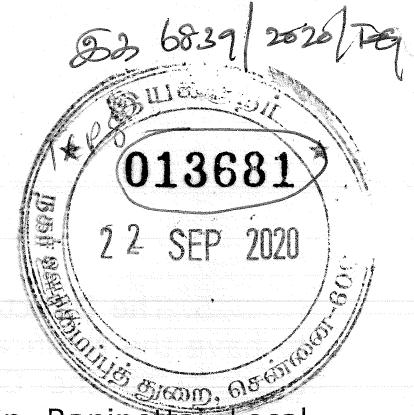

**NOTIFICATION.**

In exercise of the powers conferred by clause (b) of sub-section (1) of section 10 of the Tamil Nadu Town and Country Planning Act, 1971 (Tamil Nadu Act 35 of 1972), the Governor of Tamil Nadu hereby declares his intention to include the areas of the following revenue villages to the Ranipettai Local Planning Area and to make the following amendment to the Rural Development and Local Administration Department Notification No.II(2)/RUL/2165/74, published at pages 222 of Part II-Section 2 of the Tamil Nadu Government Gazette, dated the 17<sup>th</sup> April 1974.

2. Notice is hereby given that any inhabitant or any local authority or institution in the above said areas may, within two months from the date of publication of this notification in the Tamil Nadu Government Gazette, submit any objection or suggestion, in writing, on the proposed inclusion, to the Government and that the objections or suggestions, which may be received within the said period, will be taken into consideration before pursuing further action in terms of sub-section (4) of section 10 of the said Act.
