ORDER:

The Director of Town and Country Planning in his letter dated 2nd read above has stated that,

- i. The Managing Director, Tamil Nadu Urban Habitat Development Board has stated that the Tamil Nadu Urban Habitat Development Board is the Nodal Agency for the implementation of the Pradhan Mantri Awas Yojana (Urban) / Housing for All programme in Tamil Nadu. So far, under AHP, Construction of 150166 units at a project cost of Rs. 15128.27 crore in 351 schemes have been sanctioned from Government of India and Government of Tamil Nadu.
- ii. In G.O. (4D)No.30 Housing and Urban Development [UHD1(2)] Department, dated 17.05.2023, the Government has accorded administrative sanction for 4 schemes viz., 1) Kotturpuram, 2) Gandhi Nagar, 3) NN Nagar and Chindadripet and 4) BRN Garden and Revised Administrative sanction for 173 schemes totaling 177 Affordable Housing in Partnership schemes under

Pradhan Mantri Awas Yojana (Urban) with additional project cost of Rs.1069.19 Crore in following funding pattern.

- iii. Moreover, in the above Government Order, Government has ordered that the Tamil Nadu Urban Habitat Development Board should present the claim for Shelter Fund and Infrastructure and Amenities Fund allocation to the respective sanctioning committees, so that fund can be set aside for this purpose under the sources.
- iv. Based on the Government order the subject was placed before the 20th meeting of the State Infrastructure and Amenities Promotion Committee held on 06.10.2023 vide table agenda item No.16 and the Committee decided as follows:-

"The committee perused the Government order and the Government Order is taken on record. As per the revised administrative sanction, the committee decided to sanction an amount of Rs.357.52 crore from Infrastructure and Amenities fund for the additional project cost".

3. Therefore the Director of Town and Country Planning has requested the Government to issue necessary orders to accord Financial Sanction for a sum of Rs.357.52 crore from the Infrastructure and Amenities Fund towards 177 affordable Housing in Partnership schemes under Pradhan Mantri Awas Yojana (Urban) mentioned in G.O.(4D) No.30, Housing and Urban Development [UHD1(2)] Department, dated 17.05.2023.

4. The Government after careful examination have decided to accept the proposal of the Director of Town and Country Planning and accord Financial Sanction to Tamil Nadu Urban Habitat Development Board for a sum of Rs.50.00 crore (Rupees Fifty crore only) from the Infrastructure and Amenities fund towards 177 affordable Housing in Partnership schemes under Pradhan Mantri Awas Yojana (Urban).

5. The amount sanctioned in para 4 above shall be debited under the following heads of account: -

"2217 Urban Development - 05 Other Urban Development Schemes - 800 Other Expenditure - State's Expenditure - JW Assistance from Infrastructure and Amenities Fund for Schemes implemented through TNUHDB - 309 Grants-in-Aid - 02 Grants for Creation of Capital Assets".

The expenditure sanctioned in para 4 above shall be met from the State Infrastructure and Amenities Fund by adjusting under the following Head of Account: -

- (a) "2217 Urban Development - 05 Other Urban Development Schemes - 902 Deduct - Amount met from Reserve Fund - State Expenditure JB Amount met from State Infrastructure and Amenities Fund - 330 Inter Account Transfers 01-Inter Account Transfers".

- (b) "Reserve Funds not bearing interest 8229-00 Development and Welfare Fund - 200 other Development and Welfare Fund - AZ - State Infrastructure and Amenities Fund" - 802 - outgo - 02 - Not Bearing interest.

6. The amount sanctioned in para 4 above, shall be drawn by the Managing Director, Tamil Nadu Urban Habitat Development Board on the basis of progress of work and utilization certificate submitted by Tamil Nadu Urban Habitat Development Board should be contra credited into Public Deposit Account of Tamil Nadu Urban Habitat Development Board under the following head of account.

7. The Director of Town and Country Planning is authorized to prepare and submit an adjustment entry in the IFHRMS for effecting the above said transfer.

8. The Managing Director, Tamil Nadu Urban Habitat Development Board is requested to furnish a copy of this Government Order along with the details of expenditure incurred to the Director of Town and Country

Planning for making necessary adjustments regarding the contra debit entries mentioned in para 5 through the Accountant General (A&E), Chennai at the close of Financial Year 2023-2024.

9. The Managing Director, Tamil Nadu Urban Habitat Development Board is requested to send separate proposals to Director of Town and Country Planning seeking release of funds to the 177 Affordable Housing in Partnership schemes under Pradhan Mantri Awas Yojana (Urban) mentioned in G.O(4D)No. 30, Housing and Urban Development [UHD1(2)] Department, dated 17.05.2023 whenever necessary to adjust the above fund sanctioned from Infrastructure and Amenities fund.
