In the Government order second read above, the Government have amended the Notification issued with the Government Order first read above, so as to include additional villages to Perambalur Local Planning Area, which was published in the Housing and Urban Development Department Notification No.II(2)/HOU/230/2005, dated the 13th April 2005.

2. In the reference third read above the Director of Town and Country Planning has sent an amendment proposal for issue of revised orders, since Perambalur Panchayat was upgraded into third grade Municipality due to which certain villages have been added to the Municipality concerned.
