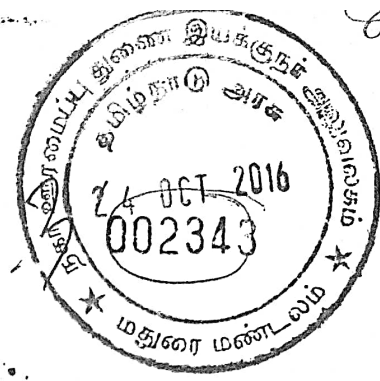

**ORDER:-**

In the Government order first read above, the Government declared its intention to specify the area comprising the Gudalur Second Grade Municipality to be a local planning area under clause (b) of sub-section (1) of section 10 of the Tamil Nadu Town and Country Planning Act, 1971(Tamil Nadu Act of 35 of 1972) and the same was published with Housing and Urban Development Department Notification No.II(2)/HOU/468/2013 at page 464 of Part-II - Section 2 of the Tamil Nadu Government Gazette, dated the 10<sup>th</sup> July, 2013 and also in the Theni District Gazette, dated the 19<sup>th</sup> February, 2015.

2. In the letter second read above, the Commissioner of Town and Country Planning has stated that objections and suggestions were not received from the public in this matter and has requested for confirmation of Notification under sub-section (4) of section 10 of the said Act.
