**ORDER:-**

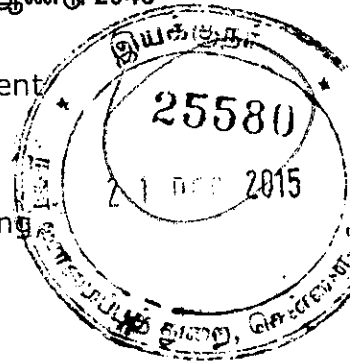
In the Government order first read above, the Government declared its intention to specify the areas comprising Vellakoil Second Grade Municipality to be a local planning area under clause (b) of sub-section(1) of section 10 of the Tamil Nadu Town and Country Planning Act, 1971(Tamil Nadu Act of 35 of 1972) and the same was published with the 10 using and urban Development Department Notification No.II(2)/HOU/ 466/2013 at page 463 of Part II - Section 2 of the Tamil Nadu Government Gazette, dated the 10<sup>th</sup> July 2013 and also in the Tiruppur District Gazette No.1, dated the 18th May 2014.

2. In the letter second read above, the Director of Town and Country Planning has stated that no objections and suggestions have been received from the public in this matter and has requested for confirmation of notification under sub-section (4) of section 10 of the said Act.

3. The Government, after careful examination, have decided to accept the proposal of the Director of Town and Country Planning in para 2 above. Accordingly, the Government declares the area specified in the Notification appended to this order, to be a vellakoil local planning area under sub-section (4) of section 10 of the Tamil Nadu Town and Country Planning Act, 1971 (Tamil Nadu Act 35 of 1971).
