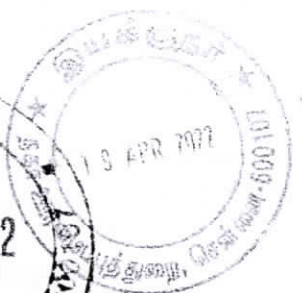

NOTIFICATION.
