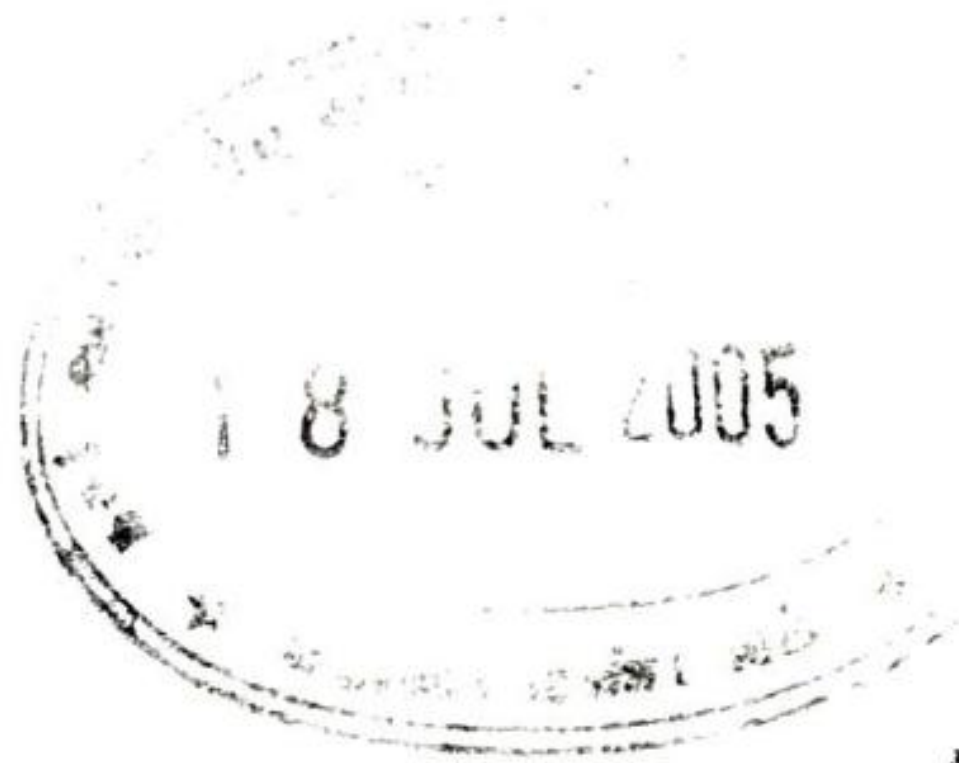

The draft Master Plan for the Usilampatti local planning area, consented to by the Government under sub-section (2) of the section 24 of the said Act is returned to the Commissioner of Town and Country Planning and he is requested to acknowledge its receipt. The Commissioner of Town and Country Planning is requested to ensure that the various requirements specified in the said Act and the Master Plan (preparation, publication and sanction) Rules are strictly adhered to by the Usilampatti local planning authority, before the master plan is resubmitted to the Government for their approval under section 28 of the said Act.

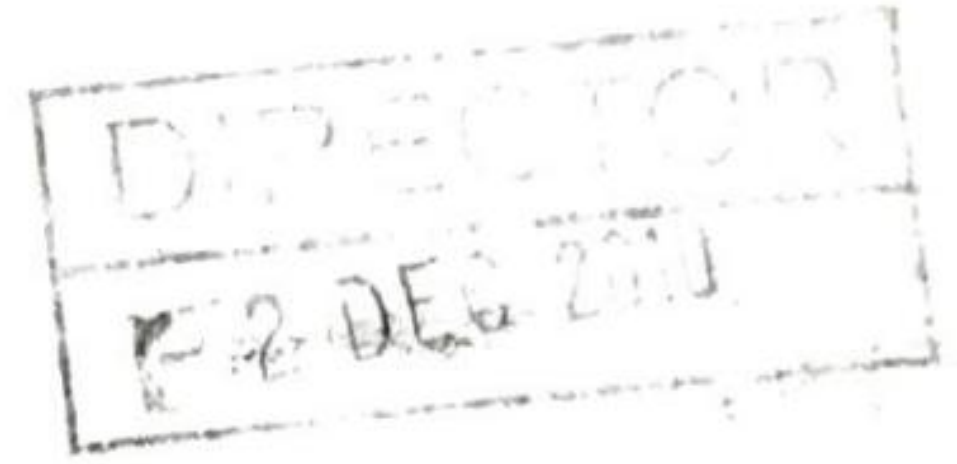

ORDER:

In the Government order first read above, the Government have accorded consent under sub-section (2) of the section 24 of the Tamil Nadu Town and Country Planning Act, 1971 (Tamil Nadu Act 35 of 1972) to the Usilampatti Local Planning Authority to the publication of a notice of preparation of the master plan under section 26 of the said Act for Usilampatti Local Planning Area.

2. The Director of Town and Country Planning in his letter second read above has forwarded the master plan for the Usilampatti Local Planning Area and requested the Government to accord approval to it under section 28 of the said Act.

3. The Government, after careful examination of the proposal of the Director of Town and Country Planning have decided to approve the master plan for the Usilampatti Local Planning Area. Accordingly, in exercise of the powers conferred by section 28 of the Tamil Nadu Town and Country Planning Act, 1971 (Tamil Nadu Act 35 of 1972), the Governor of Tamil Nadu after consultation with the Director of Town and Country Planning hereby approves the master plan for the Usilampatti Local Planning Area. The copies of the said master plan for the Usilampatti Local Planning Area, as approved by the Government, are communicated to the Director of Town and Country Planning.

4. The following Notification will be published in the next issue of the Tamil Nadu Government Gazette. The Director of Town and Country Planning is requested to ensure that the Notification is republished in the manner prescribed in rules 12 and 15 of the Master Plan (Preparation, Publication and Sanction) Rules.
