ORDER:

Nagapattinam Local Planning Area was notified and declared under sub-clauses (1) and (4) of section 10 of the Tamil Nadu Town and Country Planning Act, 1971 (Tamil Nadu Act 35 of 1972) in the Government orders first and second read above respectively.

2. During the Budget session 2016-17, while moving Demand No.26, the Minister (Housing and Urban Development) made the following announcement in the floor of Assembly:-

"The villages surrounded by the Nagapattinam shall be annexed, their boundaries be expanded and declared as Composite Local Planning Authority.

3. The Commissioner of Town and Country Planning (i/c) in his letter third read above has requested the Government to include additional areas to the Nagapattinam Local Planning Area under clause (b) of sub-section (1) of section 10 of the said Act, as Nagapattinam Composite Local Planning Authority.

4. The Government, after careful consideration of the above proposal of the Commissioner of Town and Country Planning (i/c) have decided to declare the intention of the Government to include additional areas in the Nagapattinam Local Planning Area. The appended Notification will be published in the Tamil Nadu Government Gazette.

5. The Collector of Nagapattinam District is directed to republish the Notification in the District Gazette.

6. The Director of Translation, Chennai-9, is directed to arrange to have the Notification translated into Tamil and to forward the translation urgently to the Collector of Nagapattinam District under intimation to the Government.

NOTIFICATION.

In exercise of the powers conferred by clause (b) of sub-section (1) of section 10 of the Tamil Nadu Town and Country Planning Act, 1971 (Tamil Nadu Act 35 of 1972), the Governor of Tamil Nadu hereby declares his intention to include additional areas in the Nagapattinam Local Planning Area and to make the following amendment to the Rural Development and Local Administration Department Notification No.II(2)/RUL/ 2019/74, published at page 209 of Part II-Section 2 of the Tamil Nadu Government Gazette, dated the 10th April 1974.

2. Notice is hereby given that the draft amendment will be taken into consideration on or after the expiry of two months from the date of publication of this Notification in the Tamil Nadu Government Gazette and that any objection or suggestion, which may be received from any inhabitant or any local authority or institution in the local areas, with respect thereto, before the expiry of the period aforesaid will be duly considered by the Government of Tamil Nadu.
