ORDER:

During the Budget session 2017-18, while moving Demand No.26, the Minister (Housing and Urban Development) made following announcement on the floor of Assembly.

"To declare Chidambaram and Tindivanam as Composite Local Planning Areas and Keeranur and Thirukazhukundram as Single Local Planning Areas".

2. In G.O second read above, Chidambaram Local Planning Area was declared as local planning area under sub-section (4) of section 10 of the Tamil Nadu Town and Country Planning Act 1971 (Tamil Nadu Act 35 of 1972).

3. Based on the above announcement, the Commissioner of Town and Country Planning has sent the proposal for expansion of the Chidambaram single local planning area by inclusion of additional area under clause (b) of sub-section (1) of section 10 of the said Act, as Chidambaram Local Planning Area.

4. The Government, after careful consideration of the above proposal of the Commissioner of Town and Country Planning have decided to declare the intention to include additional areas in the Chidambaram local planning area under clause (b) of sub-section (1) of section 10 of the said Act. The appended Notification will be published in the Tamil Nadu Government Gazette.

NOTIFICATION.

In exercise of the powers conferred by clause (b) of sub-section (1) of section 10 of the Tamil Nadu Town and Country Planning Act, 1971 (Tamil Nadu Act 35 of 1972), the Governor of Tamil Nadu hereby declares his intention to include additional areas in the Chidambaram local planning area and to make the following amendment to the Rural Development and Local Administration Department Notification No.II(2)/RUL/2006/74, published at page 207 of Part II-Section 2 of the Tamil Nadu Government Gazette, dated the 10th April 1974.


