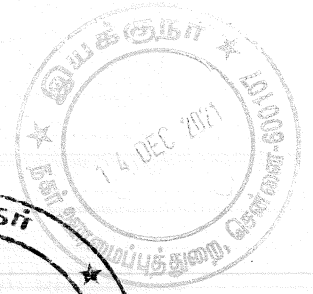
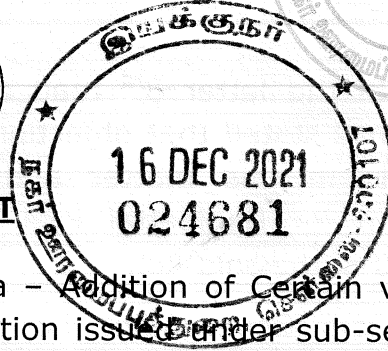

**ORDER:**

In the Government Order first read above, the Ranipettai local planning area was declared under sub-section (4) of section 10 of the Tamil Nadu Town and Country Planning Act, 1971 (Tamil Nadu Act 35 of 1972).

In the Government Order second read above, the Government notified its intention to include additional areas covered under the Ranipettai local planning area and the same was published in notification No.II(2)/HOU/656/2020 at page 679 of Part II - Section 2 of the Tamil Nadu Government Gazette, dated the 7<sup>th</sup> October 2020 and also in the Ranipettai District Gazette, dated the 22<sup>nd</sup> January 2021 for general information as required under clause (b) of sub-section (1) of section 10 of the said Act.

3. In the letter 3<sup>rd</sup> read above, the Director of Town and Country Planning has stated that objections and suggestions were not received from the public in this matter and he has requested for confirmation of Notification for Ranipettai local planning area under sub-section (4) of section 10 of the said Act.

4. The Government have after careful examination, accept the proposal of the Director of Town and Country Planning in para 3 above. Accordingly, the Government have decided to include the additional areas to the Ranipettai local planning area.

5. The appended Notification will be published in the Tamil Nadu Government Gazette.

6. The Collector of Ranipettai District is directed to republish the Notification in the District Gazette.

7. The Director of Translation, Chennai-600009 is directed to arrange to have the Notification translated into Tamil and to forward the translation urgently to the Collector of Ranipettai District under intimation to the Government.

8. The Collector of Ranipettai District is directed to report to the Government the date of republication of the notification in the District Gazette.
