In the Government Order first read above, Kangeyam Local Planning Area was declared under sub-section (4) of section 10 of the Tamil Nadu Town and Country Planning Act, 1971 (Tamil Nadu Act 35 of 1972).

2. In the Government Order second read above, orders were issued to accord administrative sanction for preparation of Master Plan for 75 towns.

3. The Director of Town and Country Planning in his letter third read above has requested the Government to include 6 additional areas in the said Kangeyam Local Planning Area under clause (b) of sub-section (1) of section 10 of the said Act.

The Government, after careful consideration of the above proposal of the Director of Town and Country Planning have decided to declare their intention to specify the areas mentioned in the Notification appended to this Order as Kangeyam Local Planning Area under clause (b) of sub-section (1) of section 10 of the said Act.

NOTIFICATION.

In exercise of the powers conferred by clause (b) of sub-section (1) of section 10 of the Tamil Nadu Town and Country Planning Act, 1971 (Tamil Nadu Act 35 of 1972), the Governor of Tamil Nadu hereby declares his intention to add the areas of the following revenue villages to the Kangeyam Local Planning Area comprising Kangeyam Second Grade Municipality, which has been declared as such vide the Housing and Urban Development Department Notification No.II(2)/HOU/227/2019, published at page 314 of Part II-Section 2 of the Tamil Nadu Government Gazette, dated the 20th March 2019, namely:-
