The Government after careful examination of the proposal of Director of Municipal Administration, sanction and release a sum of Rs.15,58,00,000/- (Rupees fifteen crore and fifty eight lakh only) towards second instalment (33%) under Infrastructure & Amenities Fund, for construction of new bus stands in Arcot, Idappadi, Ramanathapuram, Tiruvallur, Mettur, Chidambaram and Usilampatti Municipalities.

5. The amount sanctioned in para 4 above shall be debited to the following head of account:-

The Director of Municipal Administration is authorized to draw and disburse the amount sanctioned in para 4 above to the concerned Municipalities.

The Director of Municipal Administration shall furnish a copy of this Government Order along with the details of expenditure incurred out of the funds sanctioned in para 4 above to the Director of Town and Country Planning and the Accountant General (A&E), Chennai, for making necessary adjustment entries mentioned in para 5 above.


