The following draft of a Notification, which is proposed to be made in exercise of the powers conferred by clause (b) of sub-section (1) of section 10 of the Tamil Nadu Town and Country Planning Act, 1971 (Tamil Nadu Act 35 of 1972), is hereby published for general information of the public as required under sub-section (3) of section 10 of the said Act.
