**ORDER:**

In his letter read above, the Commissioner of Town and Country Planning has requested the Government to declare the Local Planning Area of Kayalpattinam under section 10 (1) of the Tamil Nadu Town and Country Planning Act, 1971 (Tamil Nadu Act 35 of 1972) on the basis of resolution No.124 of Kayalpattinam Municipality, dated 30.12.2011 and Administrative Report 2010-2011 of Kayalpattinam Municipality.

2. The Government after careful consideration have decided to accept the proposal in para 1 above and declare the local area comprising in Second Grade Municipality Area of Kayalpattinam to be a local planning area.

3. The appended notification will be published in English in the Tamil Nadu Government Gazette and republished in English and in Tamil in the Tuticorin District Gazette.

4. The Collector of Tuticorin District is requested to republish the notification in the District Gazette.

5. The Director of Translation, Chennai is directed to arrange to have the notification translated into Tamil and to forward the same urgently to the Collector of Tuticorin District.

6. The Collector of Tuticorin District is requested to report to the Government, the date of republication of the notification in the District Gazette.


