ORDER

5. The Director of Translation, Chennai-600 009, is directed to arrange to have the Notification translated into Tamil and to forward the translation urgently to the Collector of Vellore District under intimation to the Government.

NOTIFICATION.

In exercise of the powers conferred by clause (b) of sub-section (1) of section 10 of the Tamil Nadu Town and Country Planning Act, 1971 (Tamil Nadu Act 35 of 1972), the Governor of Tamil Nadu hereby declares his intention to include additional areas in the Arakkonam local planning area and to make the following amendment to the Rural Development and Local Administration Department Notification No.II(2)/RUL/2153/74, published at page 222 of Part II-Section 2 of the Tamil Nadu Government Gazette, dated the 17th April 1974.
