### ORDER:

In the Government Order first read above, Tiruppur Local Planning Area was declared under sub-section (4) of section 10 of the Tamil Nadu Town and Country Planning Act, 1971 (Tamil Nadu Act 35 of 1972).

- 2. In the Government Order second read above, certain additional areas were included in the said Tiruppur Local Planning Area.
- 3. In the Government order third read above, Government have issued orders for the constitution of Tiruppur Urban Development Authority as an adhoc body, an Advisory Council for the purpose of advising the Tiruppur Urban Development Authority on the formulation and co-ordination of plans for the development of Tiruppur Planning Area, and a Planning Cell for initiating specific plans and projects for Urban Development.
- 4. Subsequently, the Government have made amendment to the said Tamil Nadu Town and Country Planning Act, 1971 (Tamil Nadu Act 35 of 1972) vide the Tamil Nadu Town and Country Planning (Second Amendment) Act, 2022 (Tamil Nadu Act 38 of 2022), among others, to specify certain Planning Area and to constitute Urban Development

Authority. The said Amendment Act, 2022 has come into force with effect from 14.09.2022.

- 5. Based on the report of Member Secretary / Deputy Director, Tiruppur Local Planning Authority, in the letter fourth read above, the Director of Town and Country Planning has requested the Government to notify the area of 1031.67 Sq.Km., covering 10 villages (whole) forming Tiruppur Corporation, 3 villages (parts) categorized as Palladam Municipality, 4 villages (whole) and 1 village (part) classified as town panchayats and 50 revenue villages (whole) and 4 villages (part) as Tiruppur Urban Planning Area under the said section 2(48) of the Tamil Nadu Act, 1971 as inserted vide the said Amendment Act, 2022.
- 6. The Government, after careful consideration of the proposal of the Director of Town and Country Planning have decided to notify the areas specified in the notification appended to this Order as Tiruppur Urban Planning Area under the said section 2(48) and order accordingly.
- 7. The appended Notification will be published in the <u>Tamil Nadu</u> <u>Government Gazette</u>.
- 8. The Collector of Tiruppur is directed to republish the Notification in the <u>District Gazette</u>.
- 9. The Director of Translation, Chennai-9 is directed to arrange to have the Notification translated into Tamil and to forward the translation urgently to the Works Manager, Government Central Press for publication of the same in the <u>Tamil Nadu Government Gazette</u> and also to the Collector of Tiruppur District under intimation to the Government.
- 10. The Collector of Tiruppur District is directed to report to Government the date of republication of the Notification in the <u>District</u> Gazette.
