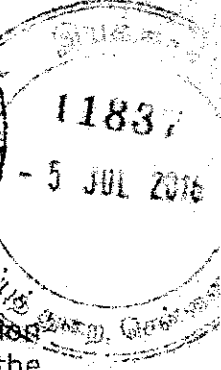
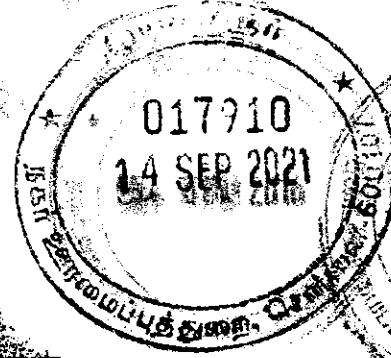

ORDER:-

In the Government Order first read above, the Government declared its intention to specify the area comprising Peranampattu Second Grade Municipality to be a local planning area under clause (b) of sub-section (1) of section 10 of the Tamil Nadu Town and Country Planning Act, 1971(Tamil Nadu Act of 35 of 1972), and the same was published with the Housing and Urban Development Department Notification No.II(2)/HOU/515/2013 at pages 488 - 489 of Part-II - Section 2 of the Tamil Nadu Government Gazette, dated the 24th July, 2013 and also in the Vellore District Gazette, dated the 5th February, 2015.

2. In the letter second read above, the Director of Town and Country Planning has stated that objections and suggestions have not been received from the public in this matter and has requested for confirmation of Notification under sub-section (4) of section 10 of the said Act.

3. The Government, after careful examination, have decided to accept the proposal of the Director of Town and Country Planning in para 2 above. Accordingly, the Government declares the area specified in the Notification appended to this order, to be a Peranampattu local planning area under sub-section (4) of section 10 of the Tamil Nadu Town and Country Planning Act, 1971 (Tamil Nadu Act 35 of 1972).
